- I. Dr. Rizki called the meeting to order at 2:32pm

Dr. Rizki informed the committee that the Budget committee would be meeting the next day in order to draft a resolution regarding the MDA plan. He asked EC members to submit recommendations regarding, but not limited to the following areas: limitation on adjuncts, duplication of services due to poor global service, concerns regarding emphasis on "growth", timeline for other revenue generators, service unit assessment, need for college level budget committees, and how to evaluate and control quality in all areas.

- IV. Dr. Rizki announced that, in years past, the Senate would formally recommend and approve the list of graduates to the President but has fallen out of practice. He instructed the Faculty Secretaries to obtain the list from the registrar for inclusion on the Senate agenda.
- V. Athletics Council
 - A. Dr. Rizki discussed that Linda Ramey has been performing double duty on the Athletics Council, serving as both the Senate representative and the CEHS representative. The EC determined that Linda should be asked to choose which seat she prefers and that a replacement should be found for the other seat.
 - B. After discussions regarding the budgeting of WSU Athletics with respect to the new MDA model, the EC decided that the Athletics Council charge should be re-worked to reflect Senate oversight, and the Senate will charge the current Athletics Council to perform a budget review of WSU Athletics in time for the February Senate meeting.
