### Meeting Notes

December 1<sup>st</sup>, 2015

- i. Meeting was called to order at 2:00
- ii. The committee welcomed Bethany Melton from the Student Government Association
- iii. The committee discussed the 2015-2016 recommended priorities:

#### Student success Center/scale-up classrooms feedback and evaluation

- In continuing the discussion on how new facilities might be assessed from faculty and students points of view, the committee was presented with a course roster for all classes held in the SSC Fall semester 2015 divided by college
- The committee discussed various ways to elicit feedback from faculty teaching courses in the SSC this semester. Options included informal/anecdotal discussions among committee members and faculty from their colleges who are teaching in the SSC, generating and informing CTL survey questions currently being implemented.

#### Direct Admit/College Transfer

- The committee reviewed the Non Academic College Dismissal Policy from UAPC and raised the following concerns:

With regards to Post-Dismissal Advising, what are the implications for Lake Campus?

- Lake to Dayton transfer issues, vice versa
  - Example: Lake engineering or nursing student is dismissed from Lake Campus for non-academic reasons and then tries to enroll in Main Campus CECS/CoNH; vice versa
- Lake Program Dismissals
  - Will Lake students dismissed from a Lake Program be sent to University College if they haven't enrolled in a new Lake program after "their next enrolled semester"?

With regards to Post-Dismissal Advising language "dismissing unit will inform student that they may continue to use their current advisor":

- Assuming a student is dismissed from a college/program but can't immediately join another college/program. What are the student's options if they choose not to use their current advisor? Do they have the option of requesting another advisor from the college/program, or are there any other advising options available?

How should UC / the University handle 3-5<sup>th</sup> year undergraduates that get dismissed and are unable to enroll in a desired college/program, or are unwilling to join a college/program that they are eligible for?

- The committee discussed direct admission policies and their impact on advising services for students who are either eligible for transfer to a new college and program, or ineligible to transfer to a college and/or program as a result of academic standing

#### International Student Success

- The committee discussed the need for developing academic support services for international students
- Concerns were raised regarding the option of delegating specialized advising services to individual adviser(s) in the UC
- The committee discussed the possibility of working with UC and the UCIE to add faculty support to a proposal for international student academic support services infrastructure

#### iv. New Business:

##### College Credit Plus enrollment

- The committee was updated on enrollment data regarding recent increase in CCP enrollment. The committee will liaison with Cathy Davis from UG enrollment management to get performance data from the Fall 2015 semester.
- The committee briefly discussed possible amendments the USSC's charge, description and constituency. Chiefly, it was agreed upon that a member of the Student Government Association should be added to the committee's roster
