I. Call to Order

II. Approval of Minutes

**The minutes were approved with unanimous consent.**

III. Report of the University President or Provost

In lieu of a formal presentation, President Schrader took a few moments to address rifts that are developing between some faculty members and some students. The President thanked the Senate & AAUP-WSU Executive Committees for issuing reminders against actions that may be perceived as exploiting the power differential between faculty and students. To conclude, President Schrader expressed that she stands ready to work with faculty to mend and strengthen the faculty's relationship with the students in the months and years to come.

Additionally, President Schrader addressed inaccurate rumors regarding Provost Edwards' recent absence from a Board of Trustees committee day and for this Senate meeting, which was for a serious health issue and not due to interviewing at other institutions.

Q&A

Senator Greene asked for a sense of how many student complaints against faculty have occurred recently. President Schrader indicated that she could not go into specific details, but there has been increased activity this semester. Faculty President Doom indicated that, through conversations with the Provost, he has learned that the number of formal concerns from students is in the range of 'half a dozen or so' while informal complaints are in the dozens.

Senator Carrafiello asked about what concrete things the faculty could do to address student, staff, and faculty morale. President Schrader indicated that the more we can do together - the better, such as:

- continue dialogues as often as possible,
- opportunities to celebrate student, faculty, and staff achievements, and
- continue to work together to build enrollments.

Senator Greene asked about investigation status, total cost, and status of associated personnel related to the November 16, 2018 non-prosecution agreement regarding the H-1B visa scandal. President Schrader indicated that there will be no civil or criminal actions taken against the university. In addition to legal fees, the fine associated with the agreement is \$1 million, which was already budgeted in the FY18 budget so there will be no additional impact to the surplus or next FY budget. Regarding personnel associated with the scandal, the President indicated that it is her understanding that those involved are no longer with the university.

Senator Wooley, in relation to Senator Greene's question, asked about distinctions between the \$1 million fine and other legal expenses associated with the case. CBO Walt Branson indicated that the fine was not meant to cover attorney fees or other expenses associated with the case. President Schrader expressed that it will be good to put this issue behind us and move forward. While the university has suffered, it has also learned a lot from the issue. For the last several years, the university has used an independent auditor to audit H-1B visas, which has informed our practices. Under the non-prosecution agreement, the university will continue this auditing practice for the next two years, which simply extends what was already put into place several years ago.

Senator Carrafiello asked about Spring 2019 enrollment projections and their impact on the budget. President Schrader expressed that the budget was normalized and annualized based on the Fall 2018 enrollment reductions, and that starting Spring 2019 a week later should allow the university to pick up some late enrollments that it would have missed in previous years.
