Posthumous Degrees and Recognitions

Policy Number 3660 Executive Responsibility Provost Faculty Senate

3660.1 Posthumous Degree Definition

Posthumous degrees represent a recognition of completion of degree requirements by individuals who had been enrolled at Wright State University continuously for at least one year prior to their deaths, and who pass away having completed at least 75% of their degree completion requirements.

3660.2 Procedure for Applying for Posthumous degree

The application process may be initiated by a fulltime professional employee of Wright State University, a family member of the deceased, or legal representative. The process may be initiated for an individual whose death has not yet occurred, but for whom there is a high probability that death will occur before the next scheduled commencement. All applications will go through the following procedure described below:

- All <u>initiations for consideration</u> for posthumous degrees <u>will first</u> be forwarded to the dean of the appropriate college or school.
- The dean will then request the Office of the Registrar and the relevant degree program or college to verify that the student meets the requirements for a posthumous degree.
- Following verification from the registrar and the degree program <u>faculty</u>, the dean will forward the written recommendation for awarding the degree to the <u>Provost</u>.
- Posthumous degrees will be awarded at the next appropriate graduation ceremony in the
 twelve-month period following the death of the student, with special attention being
 given to allowing for the proper and timely notification of the family or next of kin.

3660.3 Certificate of Recognition

For applications that do not meet the eligibility criteria for a posthumous degree, those individuals will be eligible for a certificate of recognition in lieu of a posthumous degree.

3660.4 Exceptions

In the event that the deceased does not meet one or more of the components of the definition outlined in 3660.1, or an abrupt or untimely death occurs that makes it difficult to complete the procedure outlined in 3660.2 in a timely way, the Provost may accept a petition to expedite or

If at the master's degree level, the student was at least within 8 semester credit hours of meeting all degree requirements, in work already completed.
