Wright State University Academic Policy on DANTES Subject Standardized Test (DSST)

The guidelines that govern the application of transfer credit will be used to apply credit to degree requirements for students who score at or above designated minimums on DANTES Subject Standardized Test (DSST).

Individual academic departments have determined how DSST credit is to be awarded. If the department has determined that the DSST exam is the equivalent of a specific course, credit will be awarded for that class as shown above. In some instances, a department has determined that the DSST exam does not cover the equivalent content of a single course, but will award "general elective" credit according to the recommendations of the American Council on Education (ACE). In other cases, the department has determined that there is no equivalency; therefore, no credit will be awarded, and those tests are not listed in the chart.

The above course equivalencies and credit hours will be awarded only to students whose DSST scores have not already been evaluated at Wright State. Course equivalencies and credit hours are subject to change without notice and will be granted in accordance with those current when DSST scores are evaluated.
