We followed our proposed assessment plan, with only one change – we originally proposed to assess students' essays from two assignments in this course, and the UCOC suggested one assignment would be sufficient for this assessment. So we only used students' journal entries on the topic of cultural differences as the samples since this is the most relevant assignment for the learning outcome being assessed.

Thirty three journal entries were collected and assessed by the English undergraduate committee based on the four criteria specified in the assessment plan.

The writing samples assessed are early assignments in the course. In the future, we plan to assess assignments from a later part of the semester, which may be more indicative of students' learning outcomes. Assessment criteria/rubric provided by the university committee were not provided to the instructors before the semester started. Our recommendations for instructors are to incorporate these university level outcomes into the course objectives in the future as is reasonable for the student population. ENG 2320 is for international students, whose skills in English academic writing may not necessarily fully reflect their abilities to meet these university core outcomes at this level.

The results were reviewed, and recommendations were made by the English department curriculum committee.

Assessment Administration Feedback

The assessment of the courses was part of the Core assessment cycle. The assessment plan was reviewed and approved by the UCOC. The UCOC provided a presentation on tools available to assist with the assessment, including Watermark Aqua.
