I. ACTIONS TAKEN/PLANNED TO IMPROVE STUDENT LEARNING IN THE CORE

The results of the assessment results have been shared with the curriculum committee, who also acted as assessors. Results will also be shared with Dan Zehringer, Director of SoFPA.

Accessors found that the essays and the questions in the essay prompt, as well as the intent of the essay itself, was a slightly better match for the comprehension portion of the Element 4 rubric that was selected. Finding a way to connect the subject matter (the Ring Shout from the coastal Carolinas or Indian Carnatic music) to time and place was easier for the students to draw those connections between style of the music and the audience for which it was intended. Again, the term "compositional techniques" seemed to require more sophistication that the essay prompt warranted.

In general, assessors were positive about the students' demonstration of learnings outcomes being assessed. The essay prompts all were judged to be good models for assessment of learning outcome 2. It will be discussed on whether it would be a good idea to change the assignments for assessment. The ongoing discussion of finetuning the rubric used will be planned in future curriculum committee discussions.

Procedures:

Essays were selected at random implementing the following process: Going in alphabetical order, using last names, the essay of the first student of each letter of the alphabet was selected. If a letter of the alphabet had three or more students whose last name began with that letter, the first and last essays were chosen.

Once the essays were selected at random, each essay was made anonymous, all identification marks were removed as were citations. Papers were then assigned to assessors to score one to four on the selected portion of the rubric for specific assessment (Multicultural). Assessors were not assigned to assess papers from a course that they taught.

After scores were collected from the score sheet for each the rubric required for the course (Multicultural), the aggregate score was collected and in this report. If a course used the same artifacts for each of the sections, then an aggregate score of all sections was collected and averaged between the number divided by the number of essays assessed. All supporting documentation is included in folders for each course assessed. Individual score breakdown as well as percentages are include in this report.
