## I. PROGRAM LEARNING OUTCOMES

# **II. PROCEDURES USED FOR ASSESSMENT**

## A. Direct Assessment

Course reports are completed at the end of every semester for all nursing courses (NUR 3100, NUR 3300, NUR 4800/4801, NUR 4810, NUR 4830, NUR 4850, NUR 4860, NUR 4870, NUR 4880, and NUR 4890) by the course coordinator (instructor of record). The report includes a section where the course coordinator identifies and describes the evidence of achievement of the program outcomes. The report includes information about the didactic and clinical component of the courses. The methods of evaluation include, but are not limited to, comprehensive final examination, clinical evaluations, and writing assignments.

## B. Scoring of Student Work

Didactic Evaluation of Program Learning Outcomes Evaluated using a Standardized Grading Scale based on NCLEX style test questions. 90.00 and above = A 80.00 - 89.99 = B 70.00 - 79.99 = C 60.00 - 69.99 = D 59.99 and below = F Written Assignments, Discussion Boards, Group Projects, and Capstone Project which are assigned a letter grade are assessed using a rubric. Clinical evaluation of Program Learning Outcomes Students in the RN-BSN completion program includes fieldwork experience in NUR 4890. The fieldwork capstone project involves developing and implementing a project related to direct or indirect care experience. There are required components for this project.

## C. Indirect Assessment

Indirect assessment of program learning outcomes is completed as part of end-of-program and alumni surveys. The overall program satisfaction is assessed as part of the end-of-program survey (exit survey) and alumni satisfaction survey (completed 3 years after graduation). Note: This is item # IV-I of the Systematic Program Evaluation Plan (SPEP) for the nursing program. The SPEP was developed considering the requirements of our approval and accrediting bodies. The current assessment tools ask the student to evaluate how well they believe the program outcomes were met in their program of study.

Overall Interpretation of the Results 1. Course reports are done each semester, demonstrate student achievement in the course and indicate how program learning outcomes are evaluated in the course. 2. End-of-program surveys evaluation of "overall program satisfaction" reviewed in AY 2020-2021 for results from the previous year (overall satisfaction of 92%). The evaluation also asked graduates to evaluate how well the curriculum provided opportunities to meet program outcomes. Each outcome was evaluated with positive outcomes (strongly agree or agree) There was a score of 100% on all outcomes (1-9) and overall program satisfaction. 3. The alumni survey for the RN-BSN program in AY 2020-2021 were conducted in the Summer of 2020, Fall of 2020, and Spring of 2021 and were reviewed in Fall 2021. There was a score of 100% on all outcomes (1-9) and overall program satisfaction.

1. No changes recommended at this time. 2. Faculty are discussing changes to the clinical evaluation tool in order to have more specific measurable learning outcomes for each individual. 3. Standards met for the required NCLEX pass rates, (a) The NCLEX pass rate for first-time testers is 80% or higher per calendar year per campus/site and track. (CCNE standard); and (b) The NCLEX pass rate for first-time testers is at least 95% of the national pass rate per calendar year all sites combined. (OBN) 4. Standard in the SPEP was met and the assessment supported the achievement of program learning outcomes. #### IV. ACTIONS TO IMPROVE STUDENT LEARNING

Survey results were shared with the faculty at Undergraduate Curriculum Committee and Faculty Assembly when results were collated. Results were shared with the community partners by the Department Chair at her meetings with the chief nursing officers in the Dayton area. The Dean also shared results with the Dean's Advisory Board (DSAB Board) in Spring of 2021. Based on the results of surveys and input from community partners changes were made to the RN to BSN Program of Study with the removal of Pathophysiology (NUR 3100 - was replaced with a Nursing Elective) and the patterns were modified to allow for a more seamless completion of the program.
