This form allows current Federal Direct Parent PLUS Loan (PLUS Loan) borrowers to modify their Title IV Authorization selections.

Title IV Authorization

Federal regulations regarding the use of Title IV financial aid funds (Pell Grant, Supplemental Educational Opportunity Grant, Perkins Loan, Subsidized/Unsubsidized Stafford Loan, Parent PLUS Loan) awarded to students provide that an institution may directly credit Title IV awards to a student's account at the institution to satisfy current institutional charges (tuition, fees, room and board).

Additionally, Parent PLUS loan borrowers may authorize the university to apply any excess PLUS Loan funds to satisfy other outstanding charges including, but not limited to student clinic fees, parking and library fines. Parent PLUS loan borrowers may authorize the university to apply PLUS loan funds to similar prior year outstanding charges if the payment of these charges does not prevent the student from paying his or her current educational costs.
