1. ELIGIBILITY

A student may be eligible for readmission under 20 U.S.C. §1091c if the cumulative length of absences from Wright State University by reason of service does not exceed five years and the readmission request is not later than three years after the period of service or not later than two years after the end of the recovery period for a student who is hospitalized for or convalescing from an illness or injury incurred in or aggravated during the performance of service in the uniformed services. Written notification with an intended term of enrollment is required.

Uniformed Services Readmission applies to service members who perform service in the uniformed services, whether voluntary or involuntary, in the Armed Forces, including service as a member of the National Guard or Reserve, on active duty, active duty for training, or full-time National Guard duty under Federal authority (but not State authority), for a period of more than 30 consecutive days under a call or order to active duty of more than 30 consecutive days. Any student whose absence from an institution is necessitated by reason of service in the uniformed services shall be entitled to readmission to the institution within the parameters prescribed by 20 U.S. Code § 1091c and 38 U.S.C. 4301-4334.
