## **OCHER: STRS Report** – Richard Williams

Changes to the STRS health care plan-Aetna Medicare-are finished for 2023. The improvements in the plan—lowering monthly premiums and the \$600 premium rebate along with several other changes—were very welcome. These improvements were possible because the health care plan is financially very healthy. On the pension front we probably will not see a repeat of the one-time 3% COLA in 2022-23. The financial markets performed poorly in 2022 and have not improved so far in 2023. The Federal Reserve's efforts to tamp down inflation by raising interest rates and worry about the economy falling into a recession caused sell offs in both the bond and stock markets. Consequently, the STRS investment portfolio lost 9.52% for calendar year 2022. However, this unhappy return is relative to the benchmark return for other similar public pension portfolio loses of 10.90% so STRS can claim they outperformed their competition. The STRS investment portfolio continues to rank in the top 10% of public pension funds used for comparison by Callan LLC, the STRS investment consultant.

Late December saw the release of the special audit of STRS by the Auditor of the State of Ohio. This review was triggered by a highly critical report of STRS by a member of the Ohio Retired Teachers Association (ORTA). The report contained a total of 29 allegations relating to transparency, investments, cost of living adjustments and regional offices which were critical of STRS performance. The State Auditors report addressed each of these allegations in a document 57 pages in length. The whole report can be found on the STRS website. The first paragraph of the Executive Summary is quoted here:

"In summary we found no evidence of fraud, illegal acts or data manipulation related to the \$90 billion held in trust by STRS for its members. STRS' organizational structure, control environment and operations are suitably designed and well-monitored, both internally and by independent experts. These experts help assure that STRS follows applicable asset and liability measurement, reporting, investing and cash management laws, professional standards, and best practices. Our conclusions are consistent with the findings of these independent firms."
