First-time, undergraduate, bachelor-degree seeking students have twelve (12) consecutive semesters (4 years) to take advantage of the Wright Guarantee Tuition Program. This means that students must complete their bachelor degree requirements within twelve consecutive semesters to receive the guaranteed tuition rate. However, there may be times when a student is not able to complete their degree program within the 12 semesters (4 years) timeframe, and may need to appeal to receive an extension of the guaranteed tuition rate. Students enrolled for a second bachelor's degree are not eligible for the Wright Tuition Guarantee Program. Each appeal is reviewed based upon its own merit to determine whether an extension should be granted, and if so, the nature and duration of the extension.
