Continuous Quality Improvement

Institutional accreditation validates the quality of an institution's academic programs at all degree levels, whether delivered on-site, online or otherwise.

1.A. Mission Alignment

The institution's educational programs, enrollment profile and scope of operations align with its publicly articulated mission.

3.A. Educational Programs

The institution maintains learning goals and outcomes that reflect a level of rigor commensurate with college-level work, including by program level and the content of each of its educational programs.


3.F. Program Review

The institution improves its curriculum based on periodic program review.

Academic Programs



Year One – Academic Program Review

- April 2025
 - Introductory meetings with department/college and program leadership and any others assigned
- September, December, February
 - Quarterly check-ins while program completes the self-study
- March 1, 2026
 - Self-study due to the Assurance of Learning committee for review by a subgroup
- March 30, 2026
 - Assurance of Learning committee submits their review to the Office of the Provost and copy the program leadership

Year Two – Assessment Planning & Curricular Modification

- Submit any identified curricular modifications to be included in Fall 2027 catalog
 - Curricular modifications can begin at any point and do not have to wait until Year 2
 - February 1, 2027, deadline for any registration changes (pre-req, co-req, etc.) that impact registration opening in early March
 - April 1, 2027, deadline for all other curricular approvals
- Develop a three-year outcomes assessment plan
- Document strategic plan, if created
- Identify and request, with a data-informed argument, needed resources

Years Three to Five – Annual Outcomes Assessment

- Implement the assessment plan established in Year Two
- Annually assess student learning outcomes by September 30 (for the previous academic year)
- Programs in Years 1 or 2 of the cycle do NOT submit annual outcomes assessment reports
