High school students must be close to graduating before applying to the Wright Path, and current Edison State students must have a minimum 2.0 GPA.

## ***Transfer to Wright State University***

Students must earn a minimum 2.0 GPA from Edison State in order to transfer to Wright State.

Wright State processes applications as they are received. To help you make a smooth and timely transition, we recommend you submit your application by the following dates:

Fall Semester:	<b>April 1</b>
Spring Semester:	<b>October 15</b>
Summer Semester:	<b>February 1</b>

Students must apply for undergraduate admission one semester prior to completing their studies at Edison State.

In order to be admitted fully as a business major at Wright State, students will need to achieve a cumulative GPA of a 2.5. In addition, they must complete the following equivalent Wright State courses: ENG 1100, ENG 2100, ACC 2010, ACC 2020, EC 2040, EC 2050, FIN 2210, MKT 2500, MS 2040, MS 2050, and MTH 2280.

Students interested in the Business Economics major are strongly recommended to earn a minimum grade of C in ECO 221S and ECO 222S at Edison State.


