Trustees' Award for Faculty Excellence

The Wright State University Trustees' Award for Faculty Excellence is the highest award given by the university. It is an annual award given to outstanding Wright State University full-time, fully-affiliated faculty who have demonstrated a sustained and balanced contribution to the teaching, research, and professional service mission of the university. The award is intended to honor those who serve as the most outstanding of role models for all faculty.

A faculty member may receive the award only once, and may not hold an administrative position above the rank of chair. Generally, one award may be made each year.

The Trustees' Award for Faculty Excellence carries an award of \$3,500.

Nominations

Any Wright State college or unit, including the University Promotion and Tenure Committee, may nominate candidates for the Trustees' Award. The nominations should include the following:

- a cover letter summarizing the achievements of the candidate(s);
- a curriculum vitae and appropriate supporting evidence of the nominee's outstanding achievements in teaching, research, and/or professional service; and
- letters of support from the head of the nominating unit and the college/school dean.

The University Promotion and Tenure Committee will review all nominations and submit its nominee(s) to the Provost for transmittal to the President and the Board of Trustees.

We ask the Deans' offices to please submit each of your nominations for the Trustees' Award for Faculty Excellence as an electronic PDF file via secure share to franchesca.alford@wright.edu , by March 22, 2024. Each file should be named as follows: Trustees, College/School, Last Name of Nominee, Department **(for example: (Trustees, COSM, Doe, MTH).**

Distinguished Professor

The title Distinguished Professor is a special rank awarded by the Board of Trustees, in three categories:

Robert J. Kegerreis Distinguished Professor of Teaching
Brage Golding Distinguished Professor of Research
Frederick A. White Distinguished Professor of Professional Service

Nominees for Distinguished Professor of Teaching must have demonstrated outstanding skills as teachers and advisors, as evidenced by student and peer evaluations, course development, and improvement and/or scholarly publications in the area of teaching. Nominees for Distinguished Professor of Research must have produced a significant body of work in scholarship, research, or the creative arts, which brings distinction to the University and national or international recognition to the faculty member. Nominees for Distinguished Professor of Professional Service must have provided exceptional service to the University and the community through outstanding leadership and other significant contributions.

Normally, three awards will be given each year: one in teaching, one in research, and one in professional service. No more than nine distinguished professors can exist during any given year, three in each category. **There are three awards available this year, one in each category.**

No faculty member may earn the title Distinguished Professor in a particular category more than once, and no faculty member may hold the title Distinguished Professor in two categories at the same time. However, individuals who have served as Distinguished Professor in one category, e.g. Teaching, are eligible for consideration in a different category, e.g. Service.

The title of Distinguished Professor is awarded, for a three-year period, and carries an annual stipend of \$1,000 and an annual grant of \$1,500 for professional development.

Nominations

A college or school promotion and tenure committee or professional development committee should nominate candidates for these awards.

Nominees must be full-time, fully-affiliated faculty at the rank of associate professor or above. The nomination should include the following:

- a cover letter summarizing the achievements of the candidate;
- a curriculum vitae, and appropriate supporting evidence concerning the nominee's teaching, research, or professional service, depending on the category for which the faculty member is being nominated; and
- a letter of support from the dean.

The University Promotion and Tenure Committee will review the nominations and submit its recommendations to the Provost for transmittal to the President and the Board of Trustees.

We ask the Deans' offices to please submit each of your nominations for Distinguished Professor as an electronic PDF file via secure share to franchesca.alford@wright.edu, by March 22, 2024. Each file should be named as follows: DP-(Teaching, Research, or Service), College/School, Last Name of Nominee, Department (**for example: DP-Teaching, COSM, Doe, MTH**).

President's Award for Faculty Excellence: Early Career Achievement

The President's Award for Early Career Achievement recognizes excellence in teaching, scholarship, and service during the formative years (the first four years) of a junior faculty member's initial appointment. While nominees may excel in one or two areas, they must be successfully contributing in all three. **Up to three awards can be made annually.**

The Presidential Award for Early Career Achievement carries an award of \$750.

Nominations

A college or school promotion and tenure committee or professional development committee must nominate candidates for these awards.

Nominees must be full-time, fully-affiliated faculty at the rank of assistant professor. The nomination should include the following:

- a cover letter summarizing the achievements of the candidate;
- a curriculum vitae, and appropriate supporting evidence concerning the nominee's teaching, scholarship, or professional service, or description of all three, where pertinent; and
- a letter of support from the dean.

The University Promotion and Tenure Committee will review the nominations and submit its recommendations to the Provost for transmittal to the President.

We ask the Deans' offices to please submit each of your nominations for the Early Career Achievement Award as an electronic PDF file via secure share to francesca.alford@wright.edu, by March 22, 2024. Each file should be named as follows: Early Career, College/School, Last Name of Nominee, Department (**for example: Early Career, COSM, Doe, MTH**).

President's Award for Outstanding Non-Tenure Eligible (NTE) Faculty: Teaching

The President's Award for Outstanding NTE Faculty: Teaching recognizes a full-time, non-tenure track faculty members who demonstrates excellence in teaching while still successfully contributing in all aspects of faculty responsibilities, and participates in professional development. **One award will be made annually.**

The President's Award for Outstanding NTE Faculty: Teaching carries a cash award of \$750.

Nominations

Any student, staff, or faculty member may nominate an instructor or lecturer for this award. Nominees must be full-time, non-tenure track faculty at the rank of instructor, lecturer, senior lecturer, clinical instructor or clinical assistant professors. Nominations should be submitted to the department chair of the nominee and include the following:

- a cover letter summarizing the achievements of the candidate
- a curriculum vitae, and appropriate supporting evidence concerning the nominee's contributions to teaching at Wright State University
- a letter of support from the dean.

The University Promotion and Tenure Committee will review the nominations and submit its recommendations to the Provost for transmittal to the President.

We ask the Deans' offices to please submit each of your nominations Outstanding Non-Tenure Eligible (NTE) Faculty: Teaching as an electronic PDF file via secure share to franchesca.alford@wright.edu, by March 22, 2024. Each document should be named as follows: NTE Teaching, College/School, Last Name of Nominee, Department (**for example: NTE Teaching, COSM, Doe, MTH**).

President's Award for Outstanding Non-Tenure Eligible (NTE) Faculty: Service

The President's Award for Outstanding NTE Faculty: Service recognizes a full-time, non-tenure track faculty members who demonstrates excellence in service while still successfully contributing in all aspects of faculty responsibilities, and participates in professional development. **One award will be made annually.**

The President's Award for Outstanding NTE Faculty: Service carries a cash award of \$750.

Nominations

Any student, staff, or faculty member may nominate an instructor or lecturer for this award. Nominees must be full-time, non-tenure track faculty at the rank of instructor, lecturer, senior lecturer, clinical instructor or clinical assistant professors. Nominations should be submitted to the department chair of the nominee and include the following:

- a cover letter summarizing the achievements of the candidate
- a curriculum vitae, and appropriate supporting evidence concerning the nominee's contributions to university service at Wright State University
- a letter of support from the dean.

The University Promotion and Tenure Committee will review the nominations and submit its recommendations to the Provost for transmittal to the President.

We ask the Deans' offices to please submit each of your nominations Outstanding Non-Tenure Eligible (NTE) Faculty: Service as an electronic PDF file via secure share to franchesca.alford@wright.edu, by March 22, 2024. Each document should be named as follows: NTE Service, College/School, Last Name of Nominee, Department (**for example: NTE Service, COSM, Doe, MTH**).

President's Award for Faculty Mentoring

The President's Award for Faculty Mentoring recognizes faculty members who have made significant contributions to faculty success through faculty mentoring. Mentoring may take several forms, including advice on professionalism; feedback and guidance on teaching, research, and service; career coaching; and advice on how to improve work and life balance. The Award may only be awarded once to a faculty member. One award will be made annually.

The President's Award for Faculty Mentoring carries a cash award of \$750.

Nominees should have an overall record of mentoring faculty, demonstrating sustained commitment to the mentoring of faculty that results in the personal and professional development of the mentees, and contributes to a supportive environment where faculty are able to grow and openly share challenges and successes. Nominees should maintain high standards as role models for their mentees as engaged members of the University community and actively involve their mentees in research, scholarship, and/or creative activities or in professional opportunities for leadership at the University.

Nominations

- Nominees must be full-time current faculty members.
- Nominees should have served as a faculty mentor in a formal or informal capacity to one or more junior or mid-career faculty over a continuous period of time.
- This award may only be awarded once to a faculty member.

The Nomination should include the following:

- a cover letter summarizing the candidate's faculty mentoring activities and accomplishments
- a letter of support from one of the following: past or present mentees of the nominee, the nominee's Department Chair, the nominee's Dean, or other appropriate individuals, addressing
- up to two additional letters of support.

The University Promotion and Tenure Committee will review the nominations and submit its recommendation(s) to the Provost for transmittal to the President and the Board of Trustees.

We ask the Deans' offices to please submit each of your nominations for the Faculty Mentoring Award as an electronic PDF file via secure share to franchesca.alford@wright.edu , by March 22, 2024. Each file should be named as follows: MENTOR, College/School, Last Name of Nominee, Department (**for example: MENTOR, COSM, Doe, MTH**).
