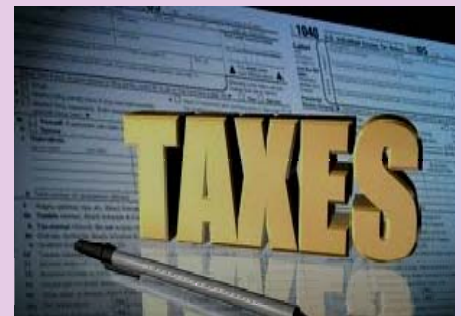

## 9) TAX FACTS –Itemized Deductions

Nonresident students and scholars (except students from India) are not permitted to take the standard deduction. While nonresident students and scholars must itemize deductions, they are limited in the type of expenses they can deduct. Expenses that can be itemized include:

- State and local taxes
- Charitable contributions
- Casualty or theft loss
- Job expenses
- Educational costs (deductible only by a person who has already worked in the field being studied, and only if the current studies will not prepare the person for a new line of work.)



For 2012, the standard deduction for students filing Single or Married Filing Separately is **\$5,950**. The personal exemption for tax year 2012 is **\$3,800**.

The only allowable itemized deduction on Form 1040NR-EZ is the state and local income tax deduction. Form 1040NR should be filed if a student or scholar has other deductions that would reduce taxable income. **Students from India can take the standard deduction on either form.**

Students and scholars who are eligible to claim family members must file Form 1040NR.
