VII. REPORT OF THE CHAIR

A. <u>Written Reports – Wright State University Board of Trustees</u> January 31, 2014

Advancement, Building & Grounds, Communications & Marketing, Enrollment Management, Multicultural & Community Engagement and Research & Sponsored Programs Reports as presented to this meeting be, and the same hereby accepted. The reports are contained in the appendix at the end of the script.

VIII. REPORT OF THE PRESIDENT

A. University Update

1. Dr. Hopkins reported that the Governor has appointed a commission in charge of quality and value. This collaboration is expected to make recommendations to the Governor by June about policies he should consider to increase the quality of higher education in Ohio. American education has evolved for 300 years. At the beginning of this century, we began to see an evolution of higher education for a 21st century model. At Wright State, it is part of our strategic plan; it is part of what we have been trying to lead. What we found in 2008 is that some of that momentum was lost, and would have to restructure the faculty roles, the way we use technology, all kinds of things. Now, it's heating up again and part of that conversation is within this initiative. Yesterday, one of the conversations was about these guiding principles and how we were trying to get working definitions of the terms "guality" and "value". One thing that Dr. Hopkins stated was that higher education is a market driven entity. We all know in higher education that students choose where they want to apply and go to college, and we also know that the federal aid will follow them to whichever college they choose. Thus, it is very important that we understand that we must be market driven. There are a growing number of people going to college, and people are beginning to understand that a college education is vital to the 21st century in terms of their quality of life. Dr. Hopkins state that there are lots of things that are going to come out of this commission and he is excited to serve on it. At the federal level, President Obama has a similar initiative going on, but

the result of that initiative will be a new ranking system that will be used to determine which universities will receive financial aid dollars in 2015. Now one of the things about being a market driven organization is that people need important and useful information about how to make decisions about their choices. Today in our country, the information parents get about higher education institutions is from sources such as US News and Report, which tell us which universities are the best, which tell us that we are stuck in an old pre-21st century method of thinking. So at the federal level, they are attempting to come up with a new ranking system that really honors the different missions of multiple institutions in our system of higher education, and we are very pleased. Mr. Tony Ortiz has been working feverishly to get Dr. Jamie Studley to come to campus. Dr. Studley is heading up this federal initiative. She wants to come to Wright State where Wright State would host a town hall sometime hopefully in April.

- 2. For the second time in four years we will have a capitol bill. Mr. Robert Hickey has reported that there is a delay based on some of the community projects. There was a time when several institutions did not receive federal funding for anything structurally based from the state of Ohio. Two years ago, they restored about \$250 million, which was still much less than what was available for the entire infrastructure we had about ten years ago. This year the government has put in another \$50 million making the total \$400 million. He felt that we are heading in the right direction. He reported that we still aren't back to where the funding was, but it is likely we will get a capitol bill in the near future.
- 3. Mr. LeRoy Butler who was a pro-baller from the Green Bay Packers was here this week as part of the Presidential Lecture Series. On March 19th, Dr. Michio Kaku will be speaking as part of the 2014 Honors Institute on Visions of the Future. Dr. Kaku is an expert on Unified Field Theory and is the Henry Semat Chair in Theoretical Physics at City University of New York.

A recently funded project included in the total is a \$235,225 award from the U.S. Department of Health and Human Services' National Institute of Mental Health to Dr. Michael Hennessy (Department of Psychology). The funding will support the development of a practical, non-human primate model to help determine if activation of the immune system resulting from social disruption contributes to depressive-like behavior, and if persisting characteristics of individuals can predict who is most vulnerable to these effects.



IX. REPORTS OF THE COMMITTEES OF THE BOARD

A. Academic Affairs Committee

Provost Report

Provost S. Narayanan reported the following:

President Hopkins was key note speaker at Sinclair Community College speaking on quality and value. He also serves with Gordon Gee on the statewide committee that was put together by Governor Kasich related to quality and value.

Through the efforts of Mr. Tony Ortiz, Wright State is planning to host the U.S. Deputy Under Secretary Jamienne Studley for a WSU Town Hall Meeting. We have offered tentative dates in February and March. This is President Obama's commission looking at quality metrics in terms of rating the higher education system.

Spring Semester Enrollment: The fourteenth day Spring semester enrollment is 16,474, which is a decrease of 1.4% from Spring 2013. The number of degree seeking students is up 0.5% for Spring 2014 versus Spring 2013. The number of non-degree seeking students is down 29%. Fall data looks encouraging with 5 to 7% more in regards to applications for the same time period last year.

Personnel: The search for the Vice President for Enrollment Management has resulted in the hiring of Ms. Mary Ellen Ashley. Ms. Shari Mickey-Boggs has been named Associate Vice President for Human Resources. Starting date for both positions was February 1st. Mr. Thomas Webb is the new director of Disability Services effective February 10th.

Communications and Marketing: Dr. Narayanan reported that the Marketing Department will be reporting to Dr. Robert J. Sweeney. The Communication Department will report to Mr. Ryan Fendley. Mr. George Heddleston has been named Chief, Communications Officer at WSRI, effective February 1st.

Ohio Board of Regents Visit February 5 and 6, 2014: Weather permitting, the Ohio Board of Regents will hold their public meeting at Wright State University on February 6th.

1. Adoption of the Statewide Remediation Standards

The following resolution was presented for approval to the Board of Trustees.

RESOLUTION 14-21

WHEREAS, Section 3345.061 of the Ohio Revised Code required the presidents of all state institutions of higher education to establish uniform statewide standards for students to be considered remediation free in mathematics, science, reading, and writing; and

WHEREAS, the adoption of statewide standards will facilitate seamless transfer of students and credit among Ohio institutions of higher education; and

WHEREAS, the adoption of statewide standards will aid school districts in preparing their students to be college ready; and

WHEREAS, Wright State University has incorporated these standards into its placement testing, course prerequisites, and curricula;

BE IT RESOLVED, that the Wright State University Board of Trustees adopts the remediation free standards recommended by the presidents.

Mrs. Broner motioned for approval. Mr. Soin seconded it, and the resolution was approved by voice vote.

Update from Vice President for Research

Dr. Robert Fyffe, vice president for Research and Graduate Studies, reported as a result of the sequester, research revenues are down for the 6-month period compared to last year, but seem to be reversing the trend, particularly in the last month. The faculty and Wright State Research Institute continue to seek and pursue diverse opportunities at the federal and state level.

The National Science Foundation last month released its higher education R&D expenditure data. In Ohio, there is a common trend

that every institution has seen a decrease in research expenditures over the past several years. WSU's research expenses are down \$2 million, much less than several of our sister institutions.

Congress and the Senate passed the Farm Bill that will now go to the President for signature. There is language in the bill that provides for 20 million dollars for the next 5 years for the Food and Agriculture Trading Consortium. WSU is a member of that consortium. The National Center for Medical Readiness, the Research Institute and some of our consultants have worked very hard to get the language in the bill that they think could lead to potentially significant funding coming to Wright State. Dr. Fyffe stated that Wright State will have to compete at a consortium level for the funding available.

• WSRI: Use-Inspired Student Research and Internships

Dr. Jason Parker, director of Wright State Research Institute, reported to the Board of Trustees on Use-inspired Student Research and Internships.

Wright State Research Institute (WSRI) is a department focused on use-inspired and applied research, emphasizing program management and a commitment to high-quality outcomes. WSRI houses not-for-profit entitles to enable their organization to move "at the speed of business." WSRI had a \$20M portfolio in FY12, including \$11M in investment by the state of Ohio. They currently staff 75 full time employees and over 50 students.

Students employed through WSRI support a variety of projects including the Image Truthing Lab (32 students, Principal Investigator: Fred Garber), the Automatic Target Recognition Center (32 students, Principal Investigator: Fred Garber), and the Summer-at the Edge (9 students, Principal Investigator: Kefu Xu). They also support a number of students through internships that provide experience in a real-world research setting.

2. Faculty Emeritus Requests

WHEREAS, Scott Fraser, Professor of the School of Professional Psychology, served the university from 1990 in a fully-affiliated and full-time status and has requested emeritus status; and

WHEREAS, Norma Shepelak, Associate Professor of Sociology, served the university from 1987 in a fully-affiliated and full-time status and has requested emeritus status; therefore be it

RESOLVED that the request for emeritus status for the aforementioned faculty members, as submitted to this meeting be, and the same hereby are endorsed.

Mrs. Broner motioned for approval. Mr. Bridges seconded it, and the resolution was approved by voice vote.

B. Finance and Audit Committee

Vice President' Report

Dr. Mark Polatajko, vice president for Business and Fiscal Affairs, reported on several activities that are currently underway within the Business & Fiscal Affairs Division.

FY14 Budget Update and FY15 Budget Development Timeline: Dr. Polatajko gave a quick overview of the FY14 Budget and the upcoming FY15 budget development timeline. The budget team conducts a re-forecast exercise as of the 15th day of the Fall semester and the Spring semester. This includes applying actual revenue and expense activity to date and forecasting the remaining year activity based upon updated assumptions. Dr. Polatajko stated there appears to be no material variances in either revenues or expenses that will cause concerns for the university from a

budget and expect no budget revisions. This re-forecast also serves as the basis for the FY15 budget compilation to which they will apply the various assumptions that were developed with the campus community and respective subject-matter experts. This FY15 budget development process began in early December and is on target to bring the budget to the Board and university community on April 17, 2014. Meetings with the Board members individually to discuss the DRAFT budget are expected to begin in mid to late March 2014.

Leading Organizational Change in the Business & Fiscal Affairs Division: Over the past 18 months, the Division has undertaken a transformative process, with an emphasis on empowering employees and leveraging talent to emerge as a high-performing organization focused on service, innovation, continuous process improvement, solution orientation and change agency. The best way to accomplish something of this magnitude is to engage employees and stakeholders in a meaningful and active manner. Dean Joanne Li offered the ideal solution - to partner with Dr. David Bright, associate professor in the Department of Management. Dr. Bright provided the Board with an overview of the organizational change process he is facilitating for the Business & Fiscal Affairs Division: Learning and Innovation Cycles thru Appreciative Inquiry. The division is scheduled to complete their organizational development work by the end of the fiscal year and then continue to work on sustaining this momentum and effort.

Mr. Rocky Doering, vice president/consultant for Fund Evaluation Group, provided a report on our investment performance for the year ended December 31, 2013.

Mr. Jeff Ulliman, controller, distributed the efficiency initiatives document. The efficiencies noted within the document are initiatives taken by the University and individual units that resulted in cost savings and cost avoidances. The objective is to develop a process to transform the annual Wright State University efficiency initiatives reporting process from a reporting/compliance approach to a methodology of driving change and transference throughout the University.

C. <u>Student Affairs Committee</u>

Vice President's Report

Dr. Dan Abrahamowicz, vice president of Student Affairs, highlighted some of the upcoming events on campus. There will be an induction of new members into the WSU Athletics Hall of Fame on February 7th. Selected for this year's honor are Mr. DaShawn Wood (star basketball player) and Mr. Joe Smith (currently playing baseball for the Los Angeles Angels). Mr. Mike Cusack, former WSU Athletic Director is also being inducted.

Other events this semester include Parents and Family Weekend to be held February 21-23rd and the 10th annual Omicron Delta Kappa Leader 2 Leader All Campus Leadership Conference planned for February 22nd.

Parents and Family Weekend will feature a men's basketball game, the selection of "Parent of the Year," and "Breakfast with the President."

Wright State's Student Union and Campus Recreation departments and Five Rivers Metro Park are again collaborating to host "Adventure Summit" the weekend of February 14th. Over 60 exhibitors have planned 40 sport related presentations for an anticipated 6,000 attendees.

For the first time ever, the All Greek (both fraternity and sorority members) grade point average (GPA) exceeds the all WSU student cumulative GPA. In addition, Wright State's Greek Life membership has grown to nearly 500 members, which is the highest level in the past 10 years.

Ms. Simone Polk, assistant vice president and Mr. Felix Torres, Food Pantry coordinator, gave an update on the operation of the WSU Friendship Food Pantry. Established in 2011 and supported completely by donations, the Pantry has 24/7 access, is staffed by 30, mostly student volunteers and served 334 client visits in 2013. Any Wright State student experiencing food insecurity or insufficiency is eligible for services. Collaborating with various campus and community partners, the WSU Friendship Food Pantry was the recipient of the 2013 President's Award for Excellence-Outstanding Collaborative Unit.

Student Government Report

Mr. Sukhman Singh, Student Government President, introduced Mr. Kyle Powell, the new Student Government Vice President who replaced Ms. Rachael Fagan following her December graduation. Mr. Powell discussed Student Government's efforts to focus on student support, community engagement and political advocacy.

Mr. Singh discussed several initiatives underway on behalf of WSU international students including supplemental language instruction for test taking, the formation of an advisory board to address student challenges and concerns, and a study of housing needs.

Student Government also supports pending state legislation that seeks to grant voting rights to student members on the Boards of Trustees at Ohio colleges and another that would offer amnesty from prosecution to individuals under age 21 who seek medical treatment for themselves or others engaged in underage drinking.

Updates

Mr. Gary Dickstein, assistant vice president for Student Affairs and

Director of Community Standards and Student Conduct (CSSC), spoke of the role of CSSC in maintaining a campus community and educating students regarding their campus and civic responsibilities. CSSC utilizes educational interventions instead of a punitive approach to increase student's awareness of more appropriate behavior and to reduce recidivism.

Minor violations of the Student Code of Conduct addressed by CSSC staff include alcohol and drug offenses, academic misconduct, thefts, and violations of quiet hours and guest policies. Other behaviors such as sexual misconduct, hazing, weapons violations and threat of harm to self or others rise to a more serious violation level and can involve outside resources such as police and the justice system.

Ms. Gabby Walsh, a senior Communications Studies major and Mr. Michael Robertson, a 3rd year medical student reflected on their experiences over the last 3 years chairing Conduct Review Panels. Both commented that the student led "Hearing Review" process works very well to encourage students to change their behavior and have been beneficial to them personally in enhancing problem solving and critical thinking skills.

Ms. Katie Deedrick, director of Student Support Services, highlighted the role of her team in supporting students who are victims of sexual assault. The 24/7 support team is with students at the hospital and continues to assist them in coping with the medical, legal and emotional issues. Student Support Services also offers educational programs for students, faculty and staff.

Wright State University has an intervention team to address concerns around students who are exhibiting inappropriate dangerous behavior. The Student Concerns Committee scans the campus to "connect the dots" between disturbing events to help prevent the threat of harm to self or others.

D. Student Trustees'Report

Ms. Tiffany Fridley felt that the Spring semester is off to a good, but chilly start for the students. It has been a somewhat odd start to the semester with the few cancellations and delays they have had, but with all of the frigid and blizzard-esque winter weather we have been experiencing, students are happy to see that the administration remains cognizant of student safety during these cold months and takes the necessary steps to ensure safe travel for all students, faculty, and staff. Social media has

shown that students have spent more time researching the effects of extreme cold and express their deep appreciation for the few days they have had that required them to bunker down and stay warm.

Due to of the vast amount of snow accumulation reported, there have been a few issues arise with parking availability for commuters on campus. However, the diligence with which the crew continues to clear out the parking lots to provide space in the limited areas we have available is appreciated.

Beyond the crazy weather concerns, classes are back in full swing and the tunnels are abuzz with life. The temperatures have guided students to the tunnels, and they greatly appreciate having a warmer avenue to traverse on their way to class.

With the arrival of the new semester, the wheels have started rolling on the upcoming changes in student leadership on campus. Student Government recently collected applications for the various roles available in the organization. Campaigning and elections are slated to begin in the near future, Ms. Fridley recognized Ms. Karli Lightner, Chief Justice of Student Government, for the excellent work she is doing conducting the election process. Additionally, the search for new Student Trustee applicants is underway. In collaboration with Student Government, exemplary students are being sought out to apply for the Student Trustee vacancy that will be available in June.

A current initiative the student trustees are working on is a collaboration with the Nutter Center that would potentially produce a student leader recognition concert series. In an effort to increase our presence on campus and to gather information from a wider range of constituencies, this concert series would provide an avenue for the Student Trustees to connect with various student leaders of organizations and academic programs in a way that enriches student experience while encouraging discussion about the state of students on campus.

An exciting endeavor and collaboration that recently happened on campus comes to us from the English department where Dr. Nancy Mack teamed up with undergraduate students to share multimedia presentations with one hundred first generation high school students about college readiness and to promote the programs offered at the university. As we look forward to the future of Wright State students, it is inspiring to see that so many departments are reaching out to high school students in the community and encouraging them to seriously consider our University. It is always an

exciting time when we get to welcome new students to campus.

In closing, the undergraduate and graduate students that have fulfilled all of the requirements for graduation have submitted their applications and are ecstatic for the ceremony that will commence in 78 days.

D. Faculty Senate President's Report

Dr. Dan Krane, Faculty President, updated the Board and guests on the activities and priorities that the Faculty Senate is engaged in at this time.

Dr. Krane expressed gratitude on behalf of the faculty to Provost Narayanan for his recognizing the faculty and staff at basketball game three weeks ago. It was a wonderful event where faculty and staff came together. It was a real sense of community, with family and children present for about two hours before the men's basketball game.

It was about a year ago now that Dr. Krane informed the Board that the Faculty Senate was well underway and embarking upon changing the faculty constitution. There have been some fairly substantial changes to the constitution that he wanted to update the Board the result of those changes. At the time he suggested that the changes were going to make the Faculty Senate much more nimble, much more efficient in terms of the important work that it does. In the past for many years we had an undergraduate curriculum and academic policies committee that found it fairly overwhelmed with both approving courses and reviewing curriculum and considering academic policies. So overwhelmed that it pretty much was forced to focus on just the course approval process and let some of the other important duties on the back burner.

Faculty Senate split that one committee into three committees without increasing the number of faculty that needed to be involved. Now they have a committee that is tasked with approving courses for the undergraduate curriculum committee. The committee is doing a fine job keeping that practice moving along.

The undergraduate curriculum review committee is looking comprehensively at all the different programs we have and making sure that there are appropriate. At our next faculty senate meeting, February 24th, a resolution is going to be presented where every program will be looked at carefully at least once every 4 years, so there is no risk of 10 to 20 years passing without this type of review. Dr. Krane stated that Wright State is in very good shape for no other reason because of the recent

transition from quarters to semesters that gave them the opportunity to do that same type of review.

The undergraduate curriculum review committee has been engaged in an analysis of the syllabi of different courses looking to see if their course attributes are appropriately identified. In an initial review of 50 syllabi, randomly chosen from across the University, about half of the syllabi did not conform to the course attributes. The committee will be looking more carefully at that and exploring why the syllabi have those problems. Once this information is obtained, the committee will be in a position where they can address those potential issues.

The third committee that was split is an undergraduate academic policies committee. This committee has been very hard at work. Dr. Krane is expecting, at the next Board meeting, the committee will be in a position to start talking to the Board about a new undergraduate admissions policy.

President Hopkins is request that a team at Wright State prepare a white paper for that quality and value commission. In addition to that white paper, the Ohio Faculty Council will be preparing a white paper in about the same timeline. Dr. Krane is hoping to have this completed by the middle of March.

Dr. Marjorie Bowman, dean of the Boonshoft School of Medicine, gave an overview of the medical school, including a brief history; information about its programs; updates on the faculty, students, residents and alumni; an explanation of its community partnerships; and a financial report on the effect of declining state support for medical education on its budget.

Dr. Bowman also highlighted new programs such as the agreement with Unaizah College of Medicine of Qassim University, Saudi Arabia, to deliver a concurrent educational experience for its students, based on the Boonshoft School of Medicine's medical education program; research excellence such as the WSU & Premier Health Neuroscience Institute and the new Clinic Trials Research Alliance; and recent statewide and national awards and honors received by

Boonshoft students.

Advancement Committee Report Wright State University Foundation Report January 2014

Market returns during the second quarter of the year continued to build on gains from the first quarter. By the end of December, our endowment portfolio had returned a positive 8.0% (benchmark data for the endowment portfolio was not available at the time this report was prepared). Equities provided the biggest boost to performance, with domestic funds slightly outperforming global investments for the period. Private equity and distressed debt investments also contributed to the positive numbers. As indicated below, the portfolio ended the second quarter with a value of \$77.3 million, up a net \$4.6 million since the beginning of the fiscal year. Actual allocations for all categories except equities were in line with targets. The over allocation to equities resulted from private equity commitments not yet called that were invested temporarily in equity funds.

The Foundation's Investment Committee met in November to continue discussions of recommendations made by our investment manager and other concerns of the group. This meeting did not result in any further changes to our asset allocation formulas, but the Committee did agree that it wanted further direction with respect to our overall allocation to stock funds, bond funds and alternative investments. Also at this meeting, the Committee was informed of the University's ITN for Investment Advisory Services. One member of the Committee and an Advancement staff member have agreed to assist in reviewing responses to the ITN.



Endowment Portfolio Composition




Endowment Historical Rates of Return

Planned Giving Update

FY14 Mid-Year Results (July 1-December 31, 2013):

Nine new planned gifts with total known value \$6,415,778. All were bequest intentions or beneficiary designations. Among the nine planned gifts was one more \$1 million+ bequest intention from a Wright State alumnus and one with a value of \$4.3 million.

As of 12/31/13, there are 12 planned gifts in discussion with a known or estimated value of \$4,145,000. There are 18 additional possible planned gifts in the early stages of discussion (with gift values yet to be determined).

Annual Giving Update

Phonathon

The Fall Phonathon Campaign concluded on October 23 and raised \$221,840 (including gifts, pledges, and matching gifts). This is already an increase from last year's total of \$146,000. This effort acquired 1,233 new donors (734 of which came from parents of current students). The Spring Phonathon Campaign will run from February 15 to April 9, 2014. The goal is to raise \$395,000 (both spring and Fall Campaigns) by April 9.

Direct Mail/eSolicitations

The FY14 Raider Club athletics appeal has raised \$36,555. This is a 66% increase over last year's appeal which raised \$21,957.

The FY14 fall appeal has raised \$30,911 (as of the 90-day check point) toward scholarships and programs that support the colleges. This is slightly lower than the 90-day check point in FY13, however, coming off a successful phonathon campaign, this is not unusual. In addition to the \$30,911 raised, many other individuals utilized their fall appeal mailing to fulfil their phonathon pledges.

The FY14 End of Year eSolicitation went out earlier this year and brought back \$7,045, which is a 48% increase over the FY13 End of Year eSolicitation.

Student Discovery Initiative

The Offices of Annual Giving, Alumni Relations, and Advancement Research and Prospect Management have partnered with Student Affairs to develop this initiative where President's Ambassadors will reach out to donor prospects on the discovery list to update contact information, build relationships, and help qualify major prospects. President's Ambassadors have received their assignments and are attempting to schedule visits.

<u>GivingTuesday</u>

Wright State's Advancement Office participated in the National Giving Tuesday festivities on December 3 to raise awareness on the importance of philanthropy, and the impact contributions to Wright State have on our students. Approximately 150 students attended the event. A follow-up blitz campaign will take place during this year's April Craze to encourage student organizations to raise funds for a new "Fund4WrightState" designation that's designed to raise enough money to provide a year tuition for 4 eligible students.

Campus Scholarship and Innovation Campaign (CSIC)

The 2013 CSIC raised \$710,776.81 toward scholarships and programs. We reached 54% participation from full-time faculty and staff. The 2014 CSIC theme is "Destination: Wright State" and materials will be distributed on March 3. A campaign kick-off is planned for February 28. For the first time this year, there will be an early-bird CSIC email solicitation that will be sent to faculty/staff prior to the campaign kick-off so that people who do not wish to receive CSIC materials can make their gift early.

BUILDINGS & GROUNDS REPORT

Friday, November 22, 2013

Neuroscience and Engineering Collaborative Building. Construction on this project has been underway since April 2013. The foundation is complete and pouring of floors is in progress. A live feed of construction activity is accessible through the Facilities Planning website.

Classroom Building. This project broke ground on October 11, 2013. Site excavation is complete and pouring of tunnel walls and foundation is underway. Construction activity can be viewed live from the Facilities Planning website.

Woods Commons. Interviews were held with six finalists for project architect. Architect selection will be complete by the end of January 2014.

Creative Arts Center. The forced design charette is complete. Estimates of design development and construction will be received in February 2014.

Dicke Balcony. Renovations to the Dicke Balcony are complete and the space is now occupied.

House Bill 7 Initiatives. ABM has completed 25 energy conservation measures (ECMS), with another 15 currently underway.

Lake Campus New Academic Building. A final draft of the project scope document for capital fundraising will be approved by January 2014.

Student Union 2nd Floor. Temporary tenants have been moved into the Student Union 2nd floor. The Program of Requirements is currently under review.

Tim Horton's. Construction is complete for the Tim Horton's venue in the Union Market. The soft opening to the public will begin January 24.

Research Park. Design planning with medical faculty continues around reworking of BSOM lab space at Research Park.

Human Services Relocation. The Department of Human Services and the LEAP program took occupancy of their new location in renovated areas of Allyn Hall.

WSU Foundation Building. Construction is complete in the WSU Foundation building, with final occupants moving in by the end of January 2014.

ODOT Shared Services. Wright State continues to develop plans, cost estimates, and the memorandum of understanding among partners (WSU, ODOT, Beavercreek, and Fairborn) around location of a shared salt storage facility to be located on the campus grounds.

Enrollment Management Report January 31, 2014

1. Undergraduate Admissions/Recruitment/Enrollment Marketing

- On Tuesday, December 10th, the Office of Undergraduate Admissions hosted a successful Transfer Open House for students transferring into Wright State for Spring Semester. Each academic college was represented, as well as many student service departments. 48 transfer students attended the event, with 35 students submitting applications to Wright State.
- December began a target generation application calling campaign. Over 6,000 students, who have expressed interest in Wright State but not yet applied, will receive a phone call encouraging them to submit a Wright State application. Phone calls also began for students who had submitted an application but not yet finished the application process.
- At the end of December, applications for Fall 2014 were running ahead with a 3% (121) increase in all new main campus undergraduate applications. An 8% (62) increase in all African American new main campus undergraduate applications.

2. Financial Aid

- Preparations for 2014-2015 financial aid processing are well underway.
 There are many changes in federal regulations this year due to enrollment reporting, so we are working through the regulation changes as well.
- Financial aid award notifications will be mailed to new students this year, instead of the standard email communications. The new paper award notification will include information on how to access WINGS Express, next steps in the enrollment process, and an estimate of costs associated with attending Wright State University. We feel that this new method for communication will assist with the enrollment of new students to Wright State University. New students will have more information at their fingertips, allowing them to make a better enrollment decision due to having the right information at the right time. Continuing students will continue to receive the

- standard email for award notifications. All communications for award notifications will begin on Friday, March 14, 2014.
- The new Federal Shopping Sheet requirement will be launched at the same time as award notifications on Friday, March 14, 2014, and will be available to all students. The Federal Requirement indicates that only Veteran students are required to receive this valuable information, however, recommends that all institutions use this information tool for all students. We will have the Federal Shopping Sheet available to all students as recommended by the US Department of Education.

3. Raider Connect

During its first semester and 'busy' season in the newly renovated space,
Raider Connect was able to assist students via 37,799 calls, 24,437 in-person
transactions, and 6,348 emails (between August 1st and December 23rd).
Raider Connect continues to collaborate with offices across campus in
seeking new improvements to streamline processes and services for
students.

4. Orientation

- Wright State University will host 16 summer orientation programs from May through August for new students to Wright State University. One additional session will be filled should the need arise in mid-August. The additional session will only be opened if we are at capacity in the first 16 sessions and necessitate an additional date.
- The programs will include presentations from each College, a student success presentation, and students will meet with their academic advisor. Several concurrent interest sessions are being created to educate families on services from Raider Connect, Student Affairs, Academic Services, etc. The common text, A Fault in Our Stars, by John Green will also be distributed to all new student attendees.
- The Admitted Student Website from the Office of Undergraduate Admissions
 will host our orientation information this year, and the online registration
 process will begin in February. The registration process for orientation will
 include a pre-orientation questionnaire so that advisors can properly advise
 new students and create an academic schedule based upon preferences.

Multicultural Affairs & Community Engagement Report to Board of Trustees January 2014

Diversity Data

Nycia Bolds, program coordinator in the Office of Multicultural Affairs & Community Engagement tasked with working to diminish the achievement gap at Wright State University, worked with Dr. Jacqueline Bergdahl and her graduate students in ABS 7100 (Research Methods I) during the fall semester 2013 to develop and implement a survey for non-returning students.

A total of 562 African-American students who attended Wright State University during the 2012-2013 academic year and did not return for the Fall 2013 semester were contacted by telephone and asked to complete a 16-question interview. Responses were collected from 57 subjects. The majority of those responding were female (61%). Majors from each college were represented. A slight majority of those completing the survey were freshmen (51%) with almost even distribution of the remaining students in sophomore through graduate student standing. The majority (56.1%) was not currently attending college and 16.0% had, in fact, already returned to Wright State. Most of those currently attending were at community colleges.

Financial issues was the primary reason given for leaving Wright State (43.9%), followed by personal reasons (24.6%). Most found financing their college education problematic (50.9%) and most reported receiving financial aid (89.5%) and reported the financial aid process as easy (56.9%). About half of the subjects (52.6%) were employed while attending Wright State, working an average of 28.7 hours per week. Most subjects (65.8%) did not believe their employment affected their academic performance. Subjects' financial situation did not change once they arrived at Wright State for most (77.2%). Of those who reported a personal issue, 29.6% reported a family issue, 22.2% another personal issue, 18.5% a personal health issue, 11.1% financial issues, 11.1% an issue with faculty or staff and 7.4% preferred not to answer.

A little over half of the total respondents (52.6%) reported having no personal issues that affected their school performance. Most subjects reported feeling like they belonged at Wright State, 49 out of 57 subjects, or 85.9%. The majority of non-returning students reported no difficulties with faculty, staff or other students (68.4%). And the majority (71.9%) was in good standing when they left. Asked about career goals, a quarter was still undecided, a quarter hoped to eventually complete a 4-year degree and 35.2% named a specific occupation they hoped to attain. Another 12.9% aspired to graduate education. Asked for advice for future Wright State students, 71.9% offered positive advice and 17.5% mentioned things to avoid. The majority of responses about what had been needed for them to have remained at Wright State were related to financing their educations, although academic and emotional support were also prominent. And financial issues was the major theme when subjects were

asked about what it would take for them to return to Wright State. Overall, these subjects' primary issue for dropping out of Wright State was financial, although academic and emotional support were also at issue.

More detailed results and strategies to address issues raised will be discussed with the Council of Deans Council and President's Cabinet during the annual diversity data report later this semester. Detailed results of the survey are available on the Multicultural Affairs and Community Engagement web page.

Programming and Events

The following are a few examples of the many programs in which staff been engaged since our last report.

The Office of Equity and Inclusion is currently conducting a search for an assistant director for the unit. Staff continues to coordinate search committee training for the campus with more than 460 faculty and staff being trained to date.

The lecture, The Meanings of "Indian Blood": Perspectives on Race and Identity took place November 19, 2013 as part of Native American History Month.

Dr. Eva Garroutte, an enrolled citizen of the Cherokee Nation, Associate Professor of Sociology at Boston College, examined the issue of Indian identity and the many competing definitions of "Indian-ness" that are rooted in law, blood, cultural practice, self-identification, and the positive and negative consequences of each as seen from the various perspectives. A crowd of 110 people (students, faculty, staff and members of the Dayton community, including Guy Jones) attended the lecture. Students from Sociology, History, and Social Work classes were given an article entitled "What if My Grandma Eats Big Mac?" written by Eva Garroutte to read in preparation for the lecture. The AHNA Center also invited faculty in Social Work and History, and staff who are interested in Native American scholarship or to learn more about the Native American culture to have lunch with Dr. Garroutte after her talk.

The Bolinga Fellows Facebook page has become a destination cyber-location for students to have dialogue, express their thoughts and connect with others. We currently have over 200 scholars signed up on the page. We use the page to help communicate with students and community members, advertise our events and take public impromptu polls on issues affecting the community.

In December the Bolinga Center held its annual Kwanzaa and Kente Stole Celebration. Approximately 125 African American students who applied for December graduation and their families were invited to attend. The director of the center reports that the overall fall programming agenda proved to be educational and empowering to students, faculty and staff. Most report that they are either satisfied or very satisfied with the information or services provided. We are in the process of developing an assessment tool that will measure the ability of our educational programs to meet learning goals and create synergy around the curriculum. We strive to make our programs support and compliment the academic mission of the University.

Upward Bound students (high school students in a program funded by the federal government to prepare them for college) participated in a hands-on career workshop on December 3, 2013. The workshop featured a focus on health and wellness by working with campus recreation staff. Participants learned about how healthy eating and exercise play key roles in learning. They were also treated to a cultural event that featured ice skating during the month of December.

Community Engagement Activities

The Multicultural Centers will collaborate with the College of Liberal Arts to conduct the Liberal Arts Pathways to Success program February 17, 2014. Prospective students from local school districts will visit the College of Liberal Arts from 9 a.m. – 12:15 p.m. for a glimpse of college life.

The Director of the Asian/Hispanic/Native American Center served as a translator for the yearly IEP for a family with a young adult daughter with special needs at Wayne High School, Huber Heights, on December 11, 2013.

The Service Knitting Circle hosted by the Women's Center made 46 cold-weather scarves and 22 cold-weather hats, 1 pair of mittens and 15 blankets. All items were donated to Hannah's Treasure Chest.

The Women's Center, along with the Southwest Ohio Consortium for Higher Education (SOCHE), hosted the Dayton area's first live stream TEDWomen event on December 5, 2013. Speakers included swimmer Diana Nyad, poet Sah Kay, speech therapist Rupal Patel, and businesswoman Sheryl Sandberg, among others. Even with the time difference between California where the program originated and Ohio, many people participated in the viewing and discussion.

Bolinga Center staff collaborated with MLK Dayton to organize a community celebration of the legacy of Martin Luther King, Jr. They also conducted programming events on campus that were open to the public including:

- Building the Beloved Community discussion
- The documentary "Letters from the Birmingham Jail"
- An on-campus march and rally

Some of the community engagement/leadership activities in which the Vice President for Multicultural Affairs & Community Engagement has been involved include serving as the Women's Leadership Chair for the Dayton United Way, serving on the Dayton Area Chamber of Commerce's Leadership Council for the Minority Business Partnership program, and representing the University on the City's Welcome Dayton Committee.

Regulatory Issues


The office is tracking the progress of the OMB "Omni-Circular" – the OMB Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards; Final Rule" – released on December 26, 2013.

An Export Compliance Task Force has been created to develop robust export control policies for the university.

Funding

Awards continue to track slightly behind last year's numbers. Our faculty, and the Wright State Research Institute, continue to seek and pursue diverse opportunities at the federal and state level.

Recently released data from the National Science Foundation shows that although most Ohio institutions have experienced a decline in research expenditures, WSU's ranking in the state has also declined over the last 5-10 years.
