VIII. REPORT OF THE PRESIDENT

A. University Update

Dr. David R. Hopkins provided an update on selected university activities:

1. Dr. Hopkins introduced two new members of our leadership team. Dr. Kimberly Barrett, vice president, Multicultural Affairs & Community Engagement, and Dr. Marjorie Bowman, dean of the Boonshoft School of Medicine.
2. The state of Ohio has asked, and funded Wright State to address the Aerospace and Defense Industries workforce talent needs. Wright State is working on multiple initiatives; the one that will be announced today is the aerospace professional development center. This is a very unique model for various industries in Ohio, we think this is a model that will sweep its way into health care, and also multiple advanced manufacturing forums. The faculty has been working diligently to be sure we have the curricula that are preparing the talent for the needs of this industry.
3. Homecoming Weekend is this weekend with all sorts of activities - a Chili Cook Off, a soccer game, and the introduction of the homecoming court on Friday. There will be all kinds of Alumni activities; with more than 400 to 500 alumni in attendance.
4. On November 28th The Ohio State President Gordon Gee and the Miami President David Hodge will be on campus to talk about the future of higher education in Ohio as part of Wright State's 45th Anniversary.
5. Governor Kasich has asked the presidents of the public universities to come up with a formula for proper financial distribution to all of the universities. Wright State as well as the presidents of all four and two year public universities will work to identify this formula, which should have a great emphasis on degree completion. When the Governor accepts the formula it will hopefully become part of the Governor's budget in either January or February.
6. Raider Connect is up and running, temporarily located in the Pathfinder Lounge. Raider Connect has already had over 1,800 phone calls in a little over a week. This is a one stop location for several of the services on campus including Bursar, Financial Aid, and Registrar.

Wright State University ended its fiscal year 2012 with a total of \$100,159,910 in external funding representing 608 awards. For the time period of July 1 – August 31, 2012 the university recorded 106 awards for a total of \$28,831,961.

Recently funded projects include a \$288,184 award from the NIH's National Cancer Institute to Dr. Madhavi Kadakia (Biochemistry/Molecular Biology-BSOM) to examine the development and progression of skin cancer and the role of Vitamin D in cancer therapy. Drs. Suzanne Franco and Jill Lindsey (Leadership Studies in Education) are recipients of US Department of Education Race to the Top funding (\$51,120) from The Ohio State University for supporting the development and implementation of the Ohio Education Research Center in Columbus, the mission of which is to conduct research on elements of Ohio's education system. Dr. Elliot Brown (Physics) was recently awarded \$232,164 from the Department of Defense's Army Research Office to support equipment acquisition and research aimed at improving the speed and accuracy of simulating and measuring bio molecular vibrations and their resonances in the THz region.

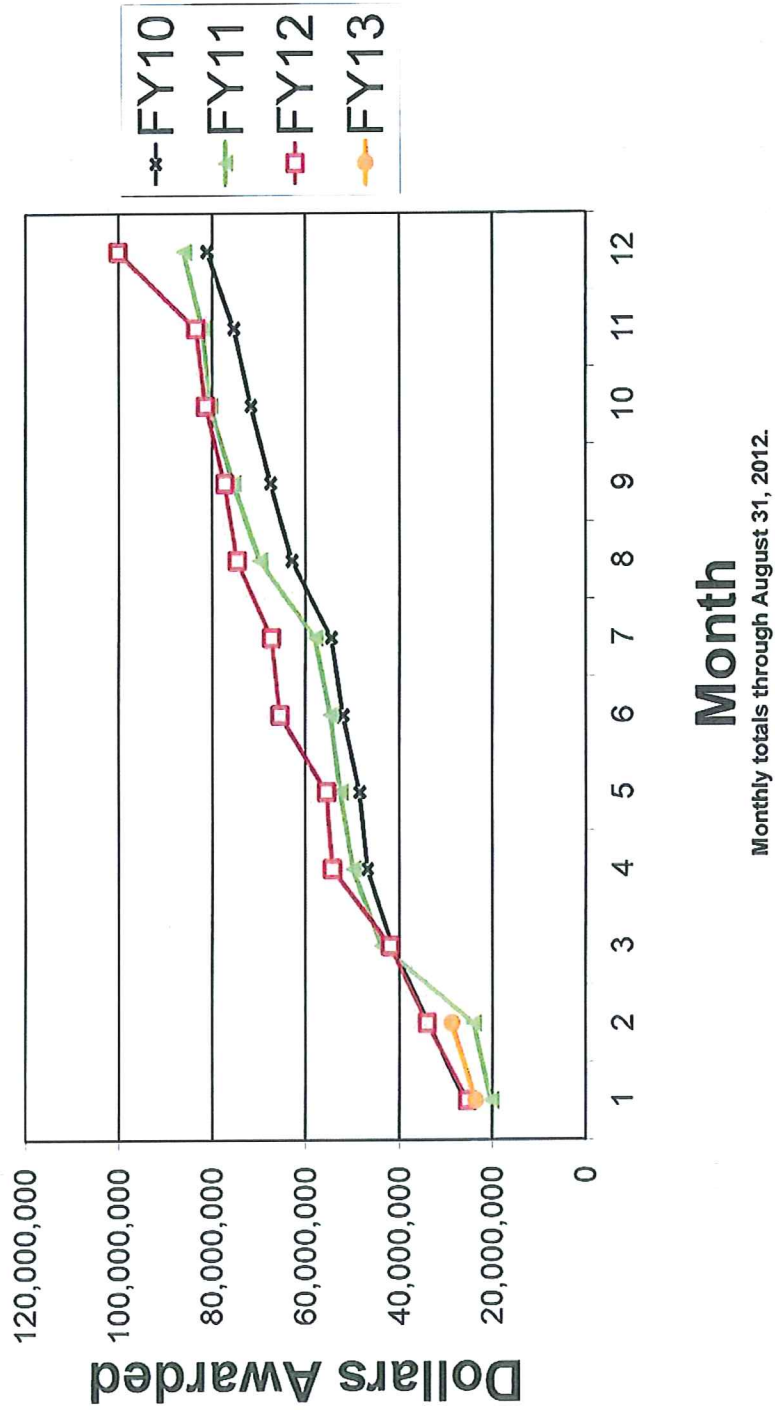

IX. REPORTS OF THE COMMITTEES OF THE BOARD

A. Academic Affairs Committee

- Provost's Report

Dr. Thomas Sudkamp presented the Provost Report.

Dr. Sudkamp recognized accomplishments of our faculty and staff, highlighting special events on campus, and reviewing administrative items.

The Dayton Business Journal has chosen President Hopkins to receive the Regional Leadership Award for 2012. The award is part of the Dayton Business Journal's Business of the Year awards program and will be presented at the awards banquet November 15 at the Schuster Performing Arts Center.

Recipients of this year's Faculty Awards for Excellence were recognized: Dr. Dean Parmalee - Robert Kegerreis Distinguished Professor of Teaching; Dr. William Cameron Chumlea - Brage Golding Distinguished Professor of Research; Dr. Thomas Sav - Frederick White Distinguished Professor of Professional Service; Drs. Katherine Excoffon, Opolot Okia, Sherrill Smith - Early Career Achievement; Ms. Sarah McGinley - Outstanding Lecturer; and Ms. Jeanine Bochenek - Outstanding Instructor. The President's Awards for Excellence honoring staff, will take place on October 10.

Dean, College of Liberal Arts Search: BLT Consulting (Buddy LeTourneau) is assisting with this search. Dr. Yi Li, dean of the College of Science and Mathematics, is chairing the committee along with Mr. Larry Klaben, chair, WSU Board of Trustees. Campus interviews are anticipated in November with the new dean to begin in January, 2013.

Provost Search: The search is just underway and Harris Search Associates has been obtained to assist with the process. The committee is being co-chaired by Dr. Dan Abrahamowicz, vice president for Student Affairs, and Dr. Rosalie Mainous, dean of the College of Nursing and Health. Mr. Vishal Soin, WSU Board of Trustees, will be serving on the committee.

WSU has been named to the Military Friendly Schools list for the fourth consecutive year. The 2013 list honors the top 15 percent of colleges, universities, and trade schools that are doing most to

embrace America's military service members, veterans, and spouses as students and ensure their success of campus.

A \$1M dollar NSF Grant led by Dr. John Gallagher to work on the development of autonomous UAVs was reported. This type of work represents an ideal mixture of scientific research and linkage to the regional economy. WPAFB is a partner on the project.

Another significant link with the regional economy is the introduction of the Aerospace Professional Development Center, October 12, 11a.m., Joshi Lobby. The project is funded by the state of Ohio to link companies with talent needed and provide workers with opportunities to enhance their employability in the aerospace industry.

Organizational changes: Graduate School, led by Dean Andrew Shu, will be reporting directly to the Provost. Currently the Graduate School reports to the Vice President for Research and Sponsored Programs. This change reflects the philosophy that academic units should report to the University's Chief Academic Officer.

Dr. Sudkamp updated the Board on the semester conversion process. Semesters began on August 27th. This was a three-year process initiated by the Ohio Board of Regents to provide better opportunities for students across the state: seamless transfer, alignment of curricula.

1. **Bachelor of Science in Engineering at Dalian**

- **Academic Partnerships**

Dr. R. William Ayres, assistant dean of Graduate School and Dr. Jill Lindsey, chair of Leadership of Education gave a presentation on Academic Partnerships. The Department of Leadership Studies in the College of Education & Human Services is partnering with Academic Partnership, a company that provides marketing, recruiting, and retention services for online programs. The programs being launched by the AP initiative are four Educational Leadership degrees; two Master degrees (MEd) in building level leadership and two Education Specialist degrees (EdS) in district-level leadership. The four programs will be delivered entirely online using a carousel model in which students take one seven-week course every eight weeks to complete five courses a year and earn their degree in two years. Leadership Studies Department Chair, Jill Lindsey, and Assistant Graduate Dean, Bill Ayres, are co-leading the AP initiative for WSU.

B. Finance and Audit Committee

• Vice President' Report

Dr. Mark Polatajko, vice president, Business and Fiscal Affairs, reported that the university has a dip in enrollment for the Fall 2012 semester. Dr. Polatajko shared a key observations, thoughts and strategies that will outline how the university is well-positioned to meet this budgetary challenge. Based on preliminary calculations, a conservative forecast of tuition revenue shows a potential negative variance of \$13 million; however, this does not consider the effect of recruiting and retention initiatives that are currently being developed to increase Spring 2013 enrollment to "buck" the trend.

He did say that other revenue line items are currently positioned for better than expected performance:

State Share of Instruction is expected to increase due to the record number of graduates the university realized in FY12 as a result of the quarter to semester conversion. Every 1% increase in SSI translates to \$800,000.

Cash flows-in have grown as expected due to more tuition dollars being realized from the conversion to semesters, which provides for more investable base and a portfolio that has performed well thus far in fiscal year 2013 with a return of over \$75,000.

Tuition --- revenue continues to increase in non-resident categories due to significant growth in international and out-of-state students. New programming targeted at new markets that will launch in time for the Spring semester are also underway.

The largest component of the university's operating budget, salaries & wages, continue to be strategically managed through a focus on managing vacancies and attrition. The current funding associated with vacant positions is approximately \$7.8 million, not including benefits of approximately \$2.3 million.

Managing vacancies may be impacted by the recently passed pension plan reform legislation, thereby, affecting our employee talent pool and institutional knowledge. There is a need for the university to be highly strategic as it continues to align these vital resources to the university mission and strategic plan.

The Team is executing on the innovative stewardship initiatives that was shared with the Board at the May 2012 Budget Workshop, with a focus on generating significant cost savings by reducing energy costs on both the supply and demand side, as well as healthcare costs. This work will positively impact the budget in FY13 and future fiscal years.

In summary, as the university nears the end of the third month of the budget year, there appears to be an approximately 4% decline in forecasted tuition revenue due to the recent enrollment activity. The Team continues to evaluate the other budgetary line items, both revenues and expenses, and is confident in the ability to manage this situation in a strategic manner.

Dr. Polatajko stated that the staff has been very busy over the summer months working on several entrepreneurial endeavors, which focus on creating value in terms of generating revenue, optimizing costs, and driving service in our operations.

A few such examples include:

- House Bill 7 Phase 2 project. The RFP is on the street and over 12 energy service companies were present at a mandatory pre-proposal hearing on August 16th. A recommendation to the Board with a recommended supplier, project scope, and an innovative financing strategy is expected at the February meeting of the Board. As a reminder, the benefit of this project is that the energy savings must exceed the debt service of financing, offering a budget-neutral, strategic approach to managing our deferred maintenance and promoting energy stewardship.
- The costs of healthcare will continue to rise over time, and we have selected a Southwest Ohio-based firm, Horan, to provide the industry expertise, negotiating power, and the data-analysis we need to make informed decisions now and in the future. In addition, the strategy of aligning this with a wellness initiative to drive a culture of wellness in terms of preventative care will help us contain healthcare costs in perpetuity.

In terms of retail operations, efforts are focused on:

- extending a relationship with Barnes & Noble, a valuable strategic partner, to generate further revenue and further value & service to our students; and,

undertaking a stakeholder perception scan and financial performance review of the university's food service operations to understand needs, objectives, opportunities for improvement, as we prepare for a competitive process which will commence this Fall to identify the best food service partner as our current contract winds-down on June 30, 2013. This is an initiative that Dr. Polatajko is co-leading with Dr. Dan Abrahamowicz.

- Mr. Dennis Obyc from Crowe Horwath LLC reviewed and commented on the Annual Audit Status Update

- **Bond Sale/Resolution**

Mr. Jeff Ulliman, Wright State University controller, introduced Mr. Andrew Brossart and Ms. Kathleen Clark from Fifth Third Securities and Ms. Allison Binkley from Benesch, Friedlander, Coplan & Aronoff, LLP.

The University has identified an opportunity to match the current favorable economic environment for issuing debt with university capital funding needs. Board approval is requested for a bond issuance not to exceed \$27.5 million. The bonds are expected to be a straight forward tax-exempt issue with an approximate interest rate of less than 3.25% over a twenty-year period. The projects to be financed include:

1. An approximate 16,000 square foot expansion to the Classroom Building.
2. Construction of a Woods Commons Building to provide a gathering space for resident student-life activities.
3. Refunding of \$14,425,000 Series 2004 Bonds which have interest rates of 4.5% - 5.0%.

The Bond Issuance resolution and will be voted on by the full Board for approval at a special meeting at noon today.

1. **Investment Policy Updates Resolution**

RESOLUTION 13-13

WHEREAS, the university has a current investment policy for its non-

endowment fund investments that is designed to maximize returns while maintaining an acceptable level of risk and the ability to meet cash flow needs, and

WHEREAS, the university in conjunction with its external consultant has performed a review of this policy for the purpose of adjusting policy language to obtain certain administrative improvements to the policy, and

WHEREAS, the university has identified certain modifications to the non-endowment investment policy as described in the attached modified policy that reflects the foregoing, therefore be it

RESOLVED that the attached non-endowment funds investment policy dated September 21, 2012 as amended in this meeting be approved, and be it further

RESOLVED that this resolution supersedes Resolution 11-47.

Dr. Joshi moved for approval. Dr. Kunesh seconded, and the resolution was approved by roll call vote.

2. Alternative Retirement Plan Amendment Resolution

RESOLUTION 13-14

WHEREAS, Wright State University (the "University") previously adopted and currently maintains the Wright State University Alternative Retirement Plan (the "Plan"); and

WHEREAS, the University reserved the right in Section 8.3 of the Plan to amend the Plan by action of the Board of Trustees; and

WHEREAS, the Board of Trustees of the University desire to amend the Plan to make certain changes in accordance with applicable revisions to the Ohio Revised Code and with the Worker, Retiree, and Employer Recovery Act of 2008; therefore be it

RESOLVED that the amendment to the Plan, in substantially the form attached hereto, be and hereby is adopted effective as stated therein; and be it further

RESOLVED that the University hereby authorizes and ratifies the actions of the Vice President for Business and Fiscal Affairs in executing the above

mentioned amendment and authorized appropriate administrators of the University to execute other instruments, documents, or conveyances necessary to effectuate the amendment; and be it further

RESOLVED that said officers, in carrying out this resolution, are hereby authorized and empowered to make any necessary changes to said amended Plan, with the advice of counsel, as may be required to ensure compliance with the applicable and effective provisions of the Internal Revenue Code of 1986, as amended, any rules and regulations thereunder, and the Ohio Revised Code.

Dr. Joshi moved for approval. Mrs. Broner seconded, and the resolution was approved by roll call vote.

- Mr. Keith Ralston, associate vice president, Budget Planning and Research Analysis, reviewed the university's expenditures of \$250,000-\$499,999. No action was required.
- Mr. Jeff Ulliman, controller, shared the university's investment reports for June and August 2012.

C. Student Affairs Committee

Vice President's Report

Dr. Dan Abrahamowicz commended Residence Services on the continued high quality of the annual "Move In" Day program. Residence Services' staff coordinated the efforts of over 500 volunteers and 120 golf carts to assist students and parents with the difficult task of moving in. This is not only an outstanding program, but a university tradition that provides an efficient and warm welcome to new students.

Fall Semester is off to a great start. Over 200 student groups registered as student organizations; setting a new record. Career Services attracted over 140 employers to their three recent successful job fairs. Nearly 700 students participated in the recruiting events focused around careers in the fields of Public Service/Creative Arts, STEM and Business. The Nutter Center hosted the Air Force Expo and 5K Run. Two thousand runners made their way across Wright State's campus during the event.

Construction updates include: the Spiritual Center is nearing completion with a formal dedication ceremony planned for October. Thanks to private donations, bleachers have been installed on Mulhollan Field and a new scoreboard will be delivered shortly. The baseball field's artificial turf and

press box project are underway.

The administration of the Wright State Friendship Food Pantry has transitioned to Student Affairs. Mr. Felix Torres, graduate student in the vice president for Student Affairs office, oversees the Food Pantry operations and coordinates the efforts of volunteers to provide emergency support to students who need their help.

Student Government Report

Mr. Joseph Gibbons, Student Government President, outlined Student Government's organizational structure and highlighted their role in representing the student body. Students are encouraged to voice their opinions and get involved with activities like the "Voter Registration and Constitution Day", the "Disability Forum" and the Student Government sponsored "Campus Blood Drive". Student Government also encourages community outreach and civic engagement by hosting events such as the C-Span Campaign Bus, English language tutoring sessions, and the Primary Care Week collaboration with area health providers.

Also introduced to the Board were Ms. Tiffany Fridley, Student Government Chief Justice, Mr. Sukhman Singh, Liberal Arts Senator and Mr. Spencer Brannon, Chief of Staff.

Updates

Mr. Dan Bertsos, director of Residence Services, presented a Residential Services' update on "Move In" Day, "First Weekend", and a new service dog training program

During "Move In" Day, Residence Services used social media to encourage students to connect with each other by tweeting and posting photos about their experience. Keeping the excitement alive, "First Weekend" included numerous programs and activities.

Resident Services' Student Weekend Activities Team (SWAT) encourages residents to stay on campus during the weekends. Averaging 300-400 students in attendance at weekend events, SWAT has developed a strong following.

Ms. Brittany Clark and Mr. Daniel Schraeder introduced their newest roommates, canines Dragon and Bitsy. As service dogs in training for the "4 Paws for Ability" group, these dogs and 10 others like them, are paired with Wright State residential students to experience new situations and learn

socialization skills. Once trained, the dogs will be matched with Autistic children as functional companions or work as alert dogs for children suffering from diabetes or seizure disorders.

Mr. Mike Martinsen, Chief of Police, discussed the staffing and duties of the Wright State Police Department. With 20 sworn certified officers on the main campus and one at Lake Campus, four administrative staff and six communication dispatchers, the department runs a full service 24/7 operation. In addition to routine patrol functions, WSU has a dog trained to deal with bomb threats, a narcotics dog for routine and specialized patrols, and officers trained in SWAT maneuvers. Tito (the drug dog) and Gali (the bomb dog) and their handlers are often requested under a mutual aid agreement to work various area sporting and political events. Recently an "Active Shooter" training scenario was held with university administration, area mutual aid law enforcement, and campus departments to insure that Wright State is prepared to address campus wide safety threats. The Police Department also provides community outreach and education in the form of crime prevention training, women's self-defense classes, and other programs.

D. Student Trustees' Report

Ms. Anne Reagan, student trustee, praised the collaboration between students and the many university departments with the transition into semesters. Walking throughout the campus this Fall, she said it was evident that our students have a strong commitment to the university community. Clubs and organizations on campus are becoming involved in the opportunities that the university has to offer. She is hopefully that by the next public session, the Governor's office will have appointed a student trustee to fill the vacated position (TJ Hufford).

E. Faculty President's Report

Dr. Dan Krane reported on the following:

Dr. Krane reported that the transition from quarters to semesters is going well; in fact problem free. That is largely due to the good work of the undergraduate and academic policies committees that paid very special attention to the details of the transition. At the Senate Committee Meeting this week a new ad hoc committee was created. The charge of this committee is to evaluate how effective our information technology systems are at Wright State and look to see if there are ways that we can improve them so as to better integrate the activities of the faculty and the curriculum

in terms of getting things done and letting students know about their status and progress. The Senate has asked the committee to report to the Faculty Senate Executive Committee by February. In addition to that the Senate is exploring where the Faculty may become more engaged in student recruitment. That is in addition to the Faculty Senate's efforts to enhance and focus on student success, Dr. Krane did note that there are four ad hoc committees in play right now that are very specifically focused on matters of student success. The first of those pertains to a first-year seminar pilot program that is well underway, and should be hearing reports from that committee in February. The second committee will become a fairly permanent committee in the sense that it will be providing oversight for the activities of the University College. The third committee is looking at ways to enhance service learning and research opportunities for our students. The fourth is one that is charged with developing a three-year plan to prepare students in area high schools that have a history of having a number of underrepresented populations of students within them. Dr. Kimberley Barrett, the new vice president for Multicultural Affairs and Community Engagement is now involved with that committee.

X. PRESENTATION AND POLICY DISCUSSIONS

Dr. Elliott Brown

**Professor, Physics and Electrical Engineering
Ohio Research Scholars Chair**

Dr. Robert Fyffe, vice president for Research and Sponsored Programs, introduced Dr. Elliott Brown.

Dr. Elliott Brown is a professor of Physics and Electrical Engineering at Wright State University where he holds the Ohio Research Scholars Endowed Chair in Sensors Physics. He is conducting research and teaching courses in RF and THz sensor science and technology, and in solid-state physics and engineering. His THz research encompasses several topics including ultra-low-noise rectifiers, photomixing sources, the THz phenomenology of biomaterials, and THz remote sensor and imager design and simulation. Other areas of research include multifunctional RF electronics and systems, biomedical ultrasonic imaging in and around hard tissue (in collaboration with the UCLA Medical and Dental Schools), and electronic and photonic transport in nanostructures. Prior to WSU Dr. Brown was a Professor of Electrical and Computer Engineering at the University of California, (Santa Barbara and Los Angeles campuses), and prior to that was a Program Manager at DARPA in the Electronics Technology Office, Arlington, VA. He earned a Ph.D. in Applied Physics from the California Institute of Technology in 1985, and did his post-doctoral work at Lincoln Laboratory, Massachusetts Institute

of Technology. Dr. Brown is a Fellow of the IEEE (since 2000) and a Fellow of the American Physical Society (since 2007). In 1998 he received an Award for Outstanding Achievement from the U.S. Office of the Secretary of Defense.

The Foundation's endowment portfolio finished the fiscal year with a modest gain of 0.7%, compared to its composite benchmark return of 1.1%. By year-end, markets had struggled back to positive territory after significant losses in the first quarter. Despite the gain, the return was not enough to cover normal endowment distributions so more of our endowments slipped below their original values. Despite this fact, all endowments received their full distribution for the year. The endowment's market value was \$68.7 million at the end of June. The portfolio continues to be overweight in our structured credit and hedge fund allocations and underweight in private equity. The Investment Committee is studying the situation and is likely to recommend a change this year. Equity and fixed income allocations are on target.

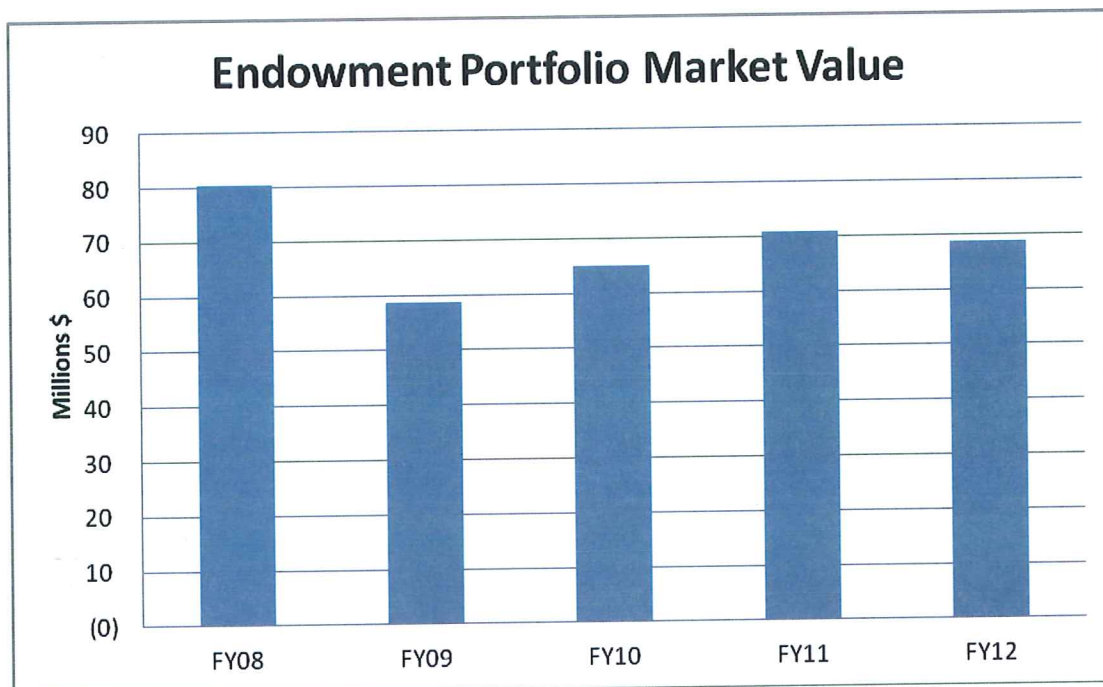
The Foundation is currently in the process of its annual audit. Although not finalized, our financial statements indicate that total assets at June 30, 2012, were \$110 million, down less than a percent from the previous year. Net assets also declined slightly, although unrestricted net assets actually increased 3% to end at \$5.3 million. Gift revenues increased slightly year over year and, of course, investment earnings declined steeply after the significant double-digit gains experienced in FY11. Cash flows from operations added to the Foundation's cash position, even though cash received from donors was down 20% from the previous year.

The Foundation's current endowment target allocation, actual allocation and market values as of June 30, 2012, are presented below:

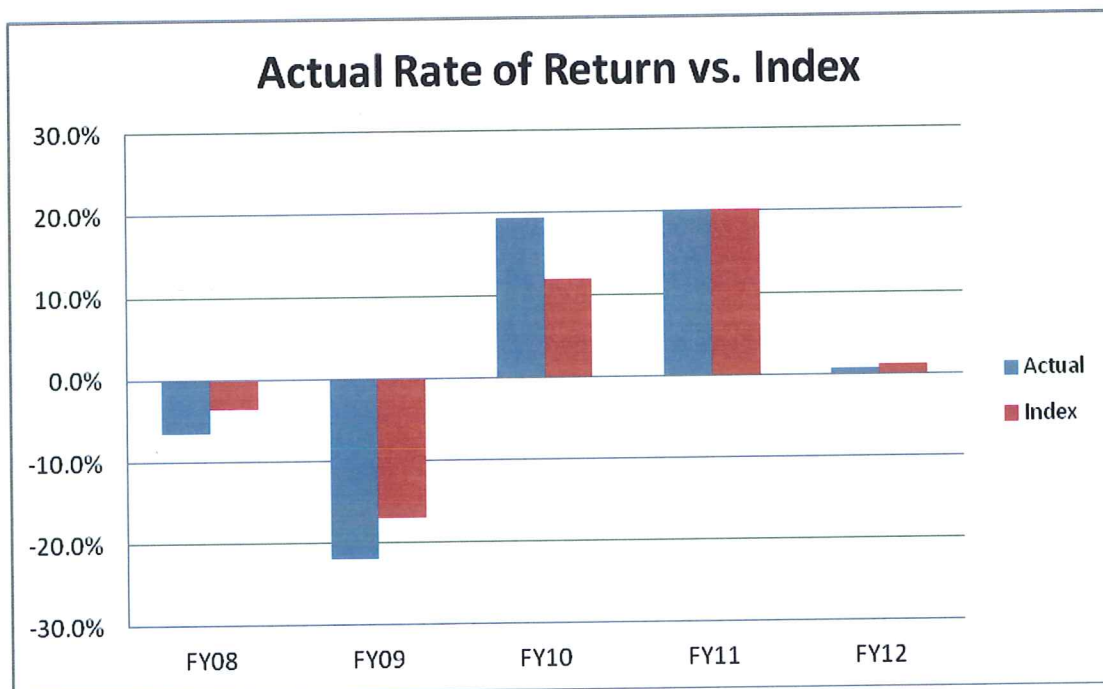

Endowment Value

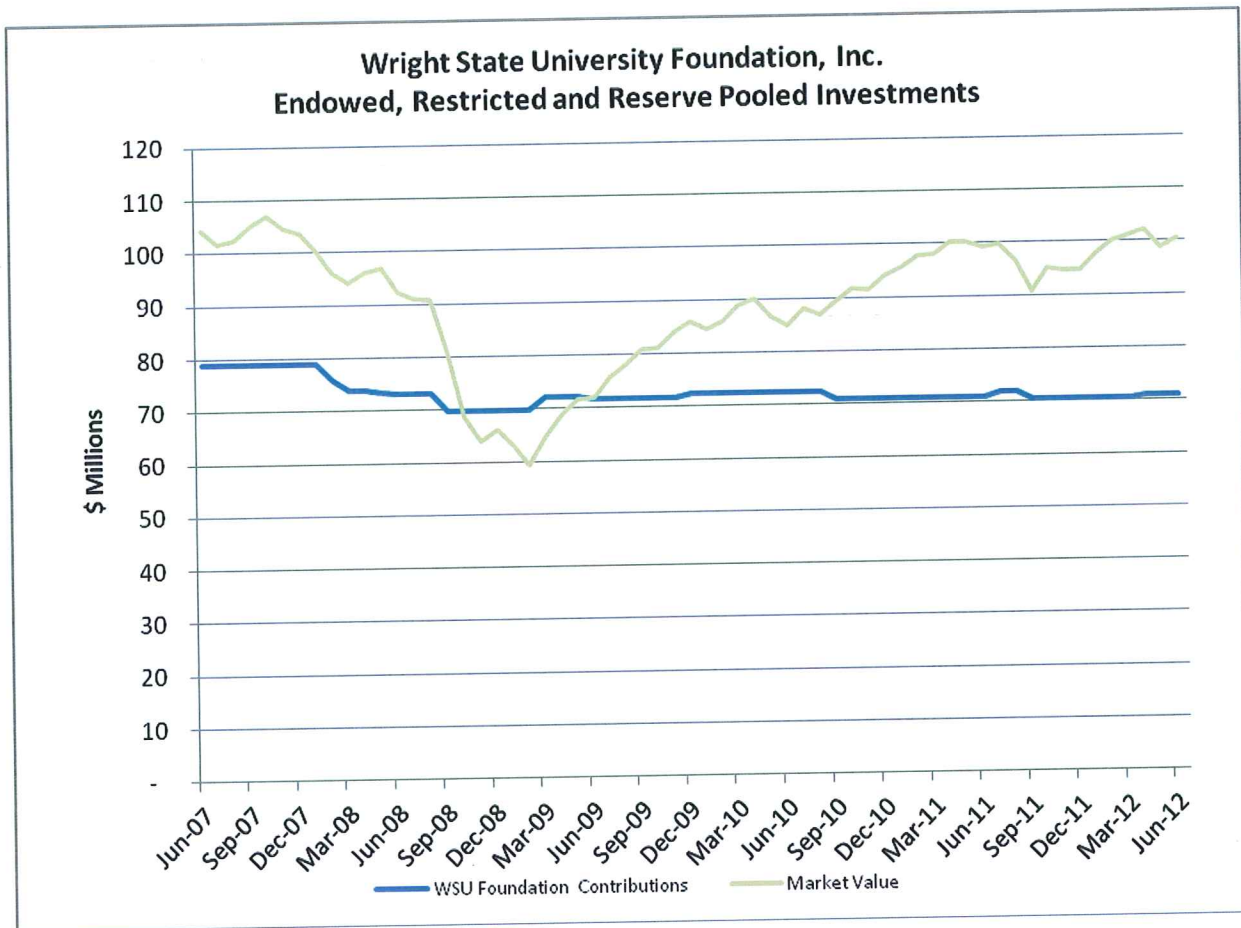


Endowment Historical Rates of Return

Planned Giving

FY12 Results:

- Recorded 20 new planned gifts with total known value \$4,109,500
- One was a charitable gift annuity; the remainder were bequest intentions
- Received proceeds from three realized bequests; total was \$359,765

This summer we closed two \$1 million and higher bequest intentions from Wright State alumni; only one other such gift from an alumni couple had been recorded up to this point.

As of 9/7/12:

- There are 12 planned gifts in discussion with a known or estimated value of \$9.4 million
- There are 21 additional possible planned gifts in the early stages of discussion (values yet to be determined)

Campus Scholarship & Innovation Campaign (CSIC)

Phonathon

- Currently piloting a new Student Development Officer initiative (see below) with CECS alumni
- Dollar Goal = \$300,000
- Participation Goal = 23%

Student Development Officer

This new initiative is intended to encourage alumni to take the time to speak to one of our phonathon callers, and to develop a more relationship-based approach to phonathon fundraising efforts. Student Development Officers will be the face and primary contact person for alumni who are assigned to them. This multichannel approach to fundraising includes the use of a pre-call mailer, monthly emails with highlights from the college in which the alum graduated, and personal phone calls. Student Development Officers will make phone calls and follow up with the response from the phone call with a personalized message ("Thank you", "Sorry I missed you", and "It was nice talking to you") to the alumni. Callers currently are not leaving messages on answering machines, but our Student Development Officers will leave messages (and a call back number) every first, fourth, and eighth attempt in hopes that the prospect will either call back or answer the phone on the next attempt. The Office of Annual Giving is currently piloting this program and if all goes well, the ultimate goal is to transition the phonathon program to a Student Development Officer program.

BUILDING & GROUNDS REPORT

Friday, September 21, 2012

Development of a Capital WrightWay Policy is underway. This policy will set the strategy, authorities, and high-level parameters relative to the capital project planning and management function at the University, which is supported by procedures, flowcharts, roles and responsibilities, and communications and training plans to ensure broad and clear dissemination of information across the university.

Architect selection is complete for the Neuroscience and Engineering Collaborative (NEC) Building. The kickoff meeting and charrette are scheduled for the week of September 24, 2012 and will be held over 2-3 days. The project liaisons assigned to this building are Dr. Timothy Cope, Dr. S. Narayanan, and Dr. Robert Fyffe.

Architect selection is complete for the Classroom Building. The kickoff meeting is scheduled for September 19, 2012. The project liaisons assigned to this building are Dr. Linda Ramey and Dr. Tim Littell.

The scale-up classroom in Russ Engineering (room 152C) is complete and operational. This room will be used as a model for scale-up classroom design in the new Classroom Building.

The target architectural solicitation date for the Creative Arts Center is December 3, 2012. Program verification will be complete in October 2012. An additional study to include renovations to the TV Center is currently underway.

Several proposed wayfinding solutions are under review. CaTS has purchased Four Winds software and is working with Facilities Planning and Development on implementation.

Construction will begin on the Raider Connect one-stop and Admissions in December 2012. Personnel will be located to a temporary space and operational by October 1, 2012.

Artificial turf installation in the Nischwitz Baseball Stadium will be complete in October 2012.

A study is underway on the Dicke Center and Dicke Balcony aimed at accommodating additional faculty offices.

The Woods programming is scheduled to begin this fall, pending outcomes of the current dining study.

Communications & Marketing Report

September 2012

Among the employees in Communications and Marketing, there are five who have served the staff for over 20 years. Each agreed that the summer of 2012 was the busiest ever in their experience. Since May, Communications and Marketing completed the online catalog, the university's courses roadmap, and many other projects on deadline for university-wide and college-specific events.

For example, ComMark met deadlines for orientation, freshman convocation, first weekend, welcome week, Regional Summit, the Dr. Ben Schuster and former President Mulhollan memorials, and more. Communications and Marketing provided overall leadership for Wright State's emergency crisis drill last spring.

In fact, it was necessary for ComMark to call on every facet of its operation – media/advertising; press relations/writing; photo/video; graphic art design; website content and web design/development for projects where every section in the unit was utilized. Examples of all-hands-needed projects were Regional Summit, freshman convocation, honors convocation, the Schuster and Mulhollan occasions, graduation, and the upcoming Heritage Dinner and Cameos of Caring annual fund-raising events.

One staff designer, Stephen Rumbaugh, undertook the task of creating special designs for the lobby of the Russ Engineering Building, the student union, and the still-in-process Raider Connect, a one-stop welcome center in the student union.

Other new creations include *Student on the Scene*, the media team's news video report featuring sophomore Reilly Dixon, who replaces last year's *Raider Recon* reporter Lara Donnelly, who graduated. Online video producer Melissa Brigden is the creative leader on these projects. Melissa also has worked on many video projects for news, as well as having produced every video interview for our website's university marketing section. This web section, comprised of testimonials about Wright State, and more, is an important component for the new Changing Lives marketing outdoor campaign, entitled "Changing Lives. How?"

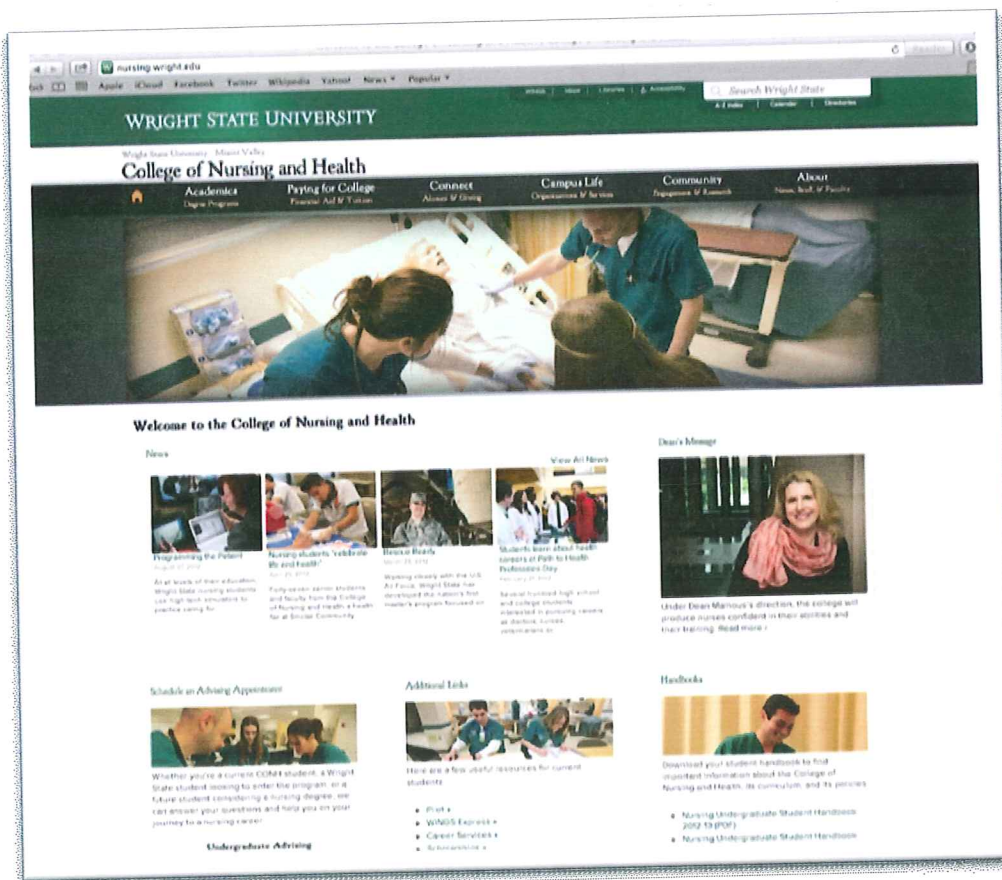
Also created was a first edition magazine for the College of Nursing and Health, *Nurse Advocate* -- one of three magazines produced over the summer, along with the Regional Summit issue of the *Wright State University Magazine* and *Vital Signs* for the Boonshoft School of Medicine.

The university newsletter, *Dialogue*, has been rejuvenated with the fall semester issue having been delivered as classes resumed. Plans call for a second semester printed issue. It will join the regularly-featured *Dialogue* faculty and staff news which posts daily online at wright.edu. Further, *Dialogue* will become the house organ used to articulate the campus effort for Wright State's five-year strategic plan.

Along the way, Communications and Marketing produced 114 original news stories for the newsroom and for use as pitch material to consumer news, created numerous landing pages on the web, produced dozens of publications for the colleges and schools, and was on the scene for hundreds of photo shoots.

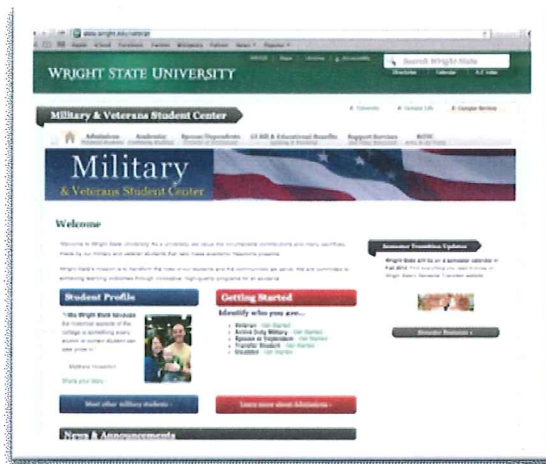

Enrollment Management Report
September 21, 2012

1. Undergraduate Admissions/Recruitment/Enrollment Marketing

- The Enrollment Management Division leadership team (Undergraduate Admissions, Enrollment Marketing, Registrar, Orientation and Financial Aid) and Institutional Research have begun a series of meetings with the college deans, department chairs, etc., to develop execute new and expanded communication plans and marketing strategies, outreach programming, identify new program and alternative program delivery opportunities and pursue improved customer/student service goals.
- Undergraduate Admissions continues to improve the efficiency of processing undergraduate applications receiving more than 90% of applications on-line. Wright State is second in the state of Ohio in receiving the most electronic transcripts. Collaborating with International Admissions, Undergraduate Admissions processed a record number of international applications for Fall 2012.

2. Financial Aid

- The Office of Financial Aid is working to implement a series of financial literacy programs in partnership with the RSCOB Wright Financial Path program and the Wright Patterson Credit Union's Savings Race. We believe that these efforts will equip students and their families to make better financial decisions, reduce the reliance on student loans, improve retention and reduce the university's loan default rate.

3. Registrar

- The Gateway Program with Clark State Community College was launched this semester with 19 students participating. The Gateway Program is designed for students interested in attending Wright State after earning an Associates degree from Clark State, students who wish to attend Wright State but are not yet academically ready for admission, and students

unable to continue their studies at Wright State due to poor academic performance. While students are officially enrolled at Clark State, complementary advising is provided by Wright State academic advisors. Participants are also eligible to use the library, participate in campus student activities, attend athletic events, use the fitness center (for a modest fee) and live in campus housing.

4. Raider Connect

- Raider Connect will open in temporary space in the Pathfinder's Lounge on October 1, 2012.
- The Enrollment Service Advisors (ESAs) who will staff Raider Connect have been identified and completed their initial eight-week training sequence in enrollment services content areas, deep customer service, and the use of an array of new technology tools that will support improved business practices.

Division of Multicultural Affairs & Community Engagement
Report to the Board of Trustees
September 17, 2012

Introduction

It is a privilege to share this, my first report to the Wright State University Board of Trustees, in the role of Vice President for Multicultural Affairs and Community Engagement. I must admit that, for me, this job is a dream come true allowing me to pursue my passion for social justice in a higher education setting. As you know the position has two complimentary responsibilities: one is to facilitate the university's work directly related to multicultural issues on campus; the other is to promote collaborations with the greater Dayton community. The goals of these collaborations are to serve the greater good, promote an understanding of the diversity that exists in our community and provide experiential learning opportunities for students, experiences that help keep the learning they do in the classroom relevant and personally meaningful.

Generally speaking, goals related to multiculturalism are to create a student body, staff and faculty whose diversity of experiences and ideas reflect our region and broader global society; to create an environment on campus free from discrimination in which all are invited to participate fully; and finally, to provide members of our campus community the knowledge and skills they need to be productive, successful and engaged citizens of a diverse, global society. My vision for the Office of Multicultural Affairs and Community Engagement is to use innovative approaches to diversity and inclusion to help all members of the campus and community achieve excellence in their various endeavors. Creating an environment in which students learn to look at the world critically and compassionately is my ultimate goal. (I am planning a retreat to develop an official mission and vision statement for the Division in October.)

News from the Division

Staffing

Events

The Women's Center's Summer Reading Selection was the common text, *Girl in Translation* by Jean Kwok. The Center's graduate assistant developed a discussion guide for the group, which was shared with First-Year Programs and UVC instructors, the English Club, and the Center for Teaching & Learning (CTL), all of which are doing programming or discussions about the book.

The Bolinga Center planned and participated in what was formerly the annual Pathway Welcome Reception and Dinner for African American students and their families. It provided a direct link to the VISION Mentoring Program to ease the transition for African American families. The program is full of information sharing, resources and opportunities to meet with faculty and staff outside of the classroom.

The Women's Center—in conjunction with the Bolinga & AHNA Centers—co-hosted a joint welcome reception for international students with UCIE and the LEAP Program with over 100 participants. Staff visited UCIE Orientation to specially invite international students to attend the event.

The AHNA Center is involved in a new collaboration with the LEAP (Learning English for Academic and Professional Purposes) program and UCIE (University Center for International Education). The projects work to help international students develop awareness regarding domestic diversity issues and to connect international students who are looking for conversation partners in English with domestic students. The first collaborative event occurred as part of the Joint Welcome Reception for international students in August.

The focus of this year's lecture series is on Latino/Latina migration to the U.S. and undocumented immigrants in Ohio; in particular, information regarding how the DREAM (Development, Relief, and Education for Alien Minors) Act will impact lives of undocumented immigrants around the nation and in Ohio.

Community Partnerships

Provided the Millett Atrium space for the Filipino community in conjunction with the Filipino Consulate in Chicago on August 25, 2012 to hold a one-day event in informing local business about business opportunities and issuing visas to those who want to travel to the Philippines.

Hosted the Dayton Minority Small Business roundtable discussion on August 28, 2012 with Farooq Mitha, Special Assistant in the Department of Defense's Office of Small Business Programs, to discuss ways in which the federal government can better serve the minority business community in Dayton. Twenty-two business members from the community attended the meeting.

Connected WSU Chinese staff and students to translate Mandarin Chinese for the ELL (English Limited Language) program at Xenia Community School District. Sherri Brown-Johnson, a WSU alumna from the College of Education, is currently the District ELL Coordinator/Teacher for Xenia High School.

The AHNA center is involved in ongoing research to identify artists/performers from Japan to bring to campus through the Japan Foundation Grant for 2013-2014.

Report to Board of Trustees

Focus: promoting culture of entrepreneurship, 'pathway to yes', enhancing customer service (internal and external). Unit directors (RSP, pre-award, post-award, technology transfer) creating 'process maps'.

Administrative Initiatives:

- InfoEd. Implementation of the InfoEd platform for grant preparation and submission, grants management, compliance (IRB, IACUC, Col, etc) is underway in a phased approach, supported by Mark Wysong, on secondment from WSRI.
- Visual Compliance – a statewide shared services agreement developed by the respective research officers enabled acquisition of software for handling export control and related issues.
- Clinical Trials and Research Alliance (CTRA). In partnership with PHP, the IRB structure for the region has been transformed. Separate IRBs have been unified and the WSU IRB is now the effective IRB of record for physicians, students, researchers and healthcare professionals across our institutions.
- Hanover Research – Grant Development Services.
- Shared equipment inventory and maintenance.
- Compliance Officer search.
- Tech Transfer director search.

External Issues:

- OhioLink – severance of fiscal agency role for WSU (impact on RSP - \$15M shows as RSP award; total ~ \$40M on WSU books).
- OMB Sequestration Transparency Act Report 9/14/2012
Impact: Sequestration would result in a 9.4 percent reduction in non-exempt defense discretionary funding and an 8.2 percent reduction in non-exempt nondefense discretionary funding. The sequestration would also impose cuts of 2.0 percent to Medicare, 7.6 percent to other non-exempt nondefense mandatory programs, and 10.0 percent to non-exempt defense mandatory programs. For example, for NIH, the report indicates that \$30.711 billion would be subject to the 8.2 percent sequester, equal to \$2.518 billion, and an additional \$150 million in mandatory budget authority (for diabetes research) would be subject to a 7.6 percent cut, equal to \$11 million. The total cut to NIH would equal \$2.529 billion.

Model for Startups

- New venture established around specific commercialization opportunity
 - Led by CEO
 - Staffed with student employees
 - Two from research area (PI's lab)
 - Two from business school (Marketing/Finance)
- Equity held by University, PI, employees, investment partners
- Five person board established by WSU and investment partner
- Center for Innovation Management advises and supports venture



Selection Process for Business School Candidates

- Identify 10 interesting students
 - Five with marketing focus
 - Five with Finance focus
- Present background on technology and research
- Student teams take 10 days to develop a presentation that outlines their view of
 - The marketing opportunity
 - Pathways to market
 - Barriers to success
- Final selection of candidates made by a review board



Summary

- Desired outcome is **SUCCESS**
 - Win-win-win for university, researchers, students community etc...
 - Operates under the premise that some % of something is better than 100% of nothing
- Leverages the full suite of university capabilities including graduate programs and research infrastructure
- Facilitates student success in an academic and entrepreneurial culture
