VIII. REPORT OF THE PRESIDENT

A. University Update

President David R. Hopkins provided an update on selected university activities:

1. Last week Governor Kasich held a meeting in which he announced that there is another commission. The Governor has been very thoughtful in terms of creating commissions that would allow the university presidents and their teams to really look at some of the difficult issues facing Ohio. Four years ago there was no money coming from the state in regards to renovation, maintenance and new construction. Two years ago, a commission was formed by the Governor to look at a new process that a capitol bill might be distributed to the institutions across the state. That process was very successful and two years ago Wright State received money comparable to leels received 10 years ago. He reinvigorated this commission last week. This commission will look at how to distribute a capitol bill of dollars identified for higher education, with a focus on differed maintenance. Also, at that meeting the Governor announced his intention to form a second commission that will look at the important things like value and quality in higher education. President Obama has also created an initiative to look at value at the federal level that will relate to the way federal student aid is distributed in 2015. There is a major emphasis on the type of value being provided in terms of success and access for students. Dr. Hopkins said what we do in Ohio will have an influence on what we are doing at the federal level on policy formation. Many know that a year ago the Governor was very insightful in creating a higher education funding commission that allowed everyone to work very hard on changing the formula for the way education is funded in the state of Ohio. That model is now being lifted up by President Obama to universities all across the country.
2. October is a busy time and the energy on campus this year is much greater than the 10 years Dr. Hopkins has been here. He thought it was a sign of students engaging in learning and engaging with their professors and with each other. He noted that

the Diversity in the Multicultural Millennium Conference was going on today. Last night's dinner was moved to the Nutter Center because of the large number attending. Thanks to Dr. Kimberly Barrett's leadership. Monday, October 11th the 3rd Annual Wright Brothers Day in the Student Union will take place. It is organized by the Raj Soin College of Business Marketing Club and is run entirely by students and is a great celebration of Wright State's heritage. Next Friday October 11th at 2 p.m. the ground breaking the new Student Success Center/ Classroom Building will take place. It will not only bring all of our student support systems to one location, but even more importantly are the classrooms. Dr. Hopkins thanked the Board of Trustees for their support on this endeavor, stating that Wright State is really in a position to lead the state on this new concept of blended learning. We are using digital learning to bring students to class with more content knowledge and they are really using the classroom to participate in that face-to-face collaborative learning environment, which Dr. Hopkins thinks is going to be the model of the future.

3. Finally, on October 18th, Wright State will host a strategic planning day on campus, celebrating where we have been in the last five years and all of the accomplishments of our strategic plan, but most importantly, it is to celebrate the kickoff of our new strategic plan. There will be events going on in every college all across campus.

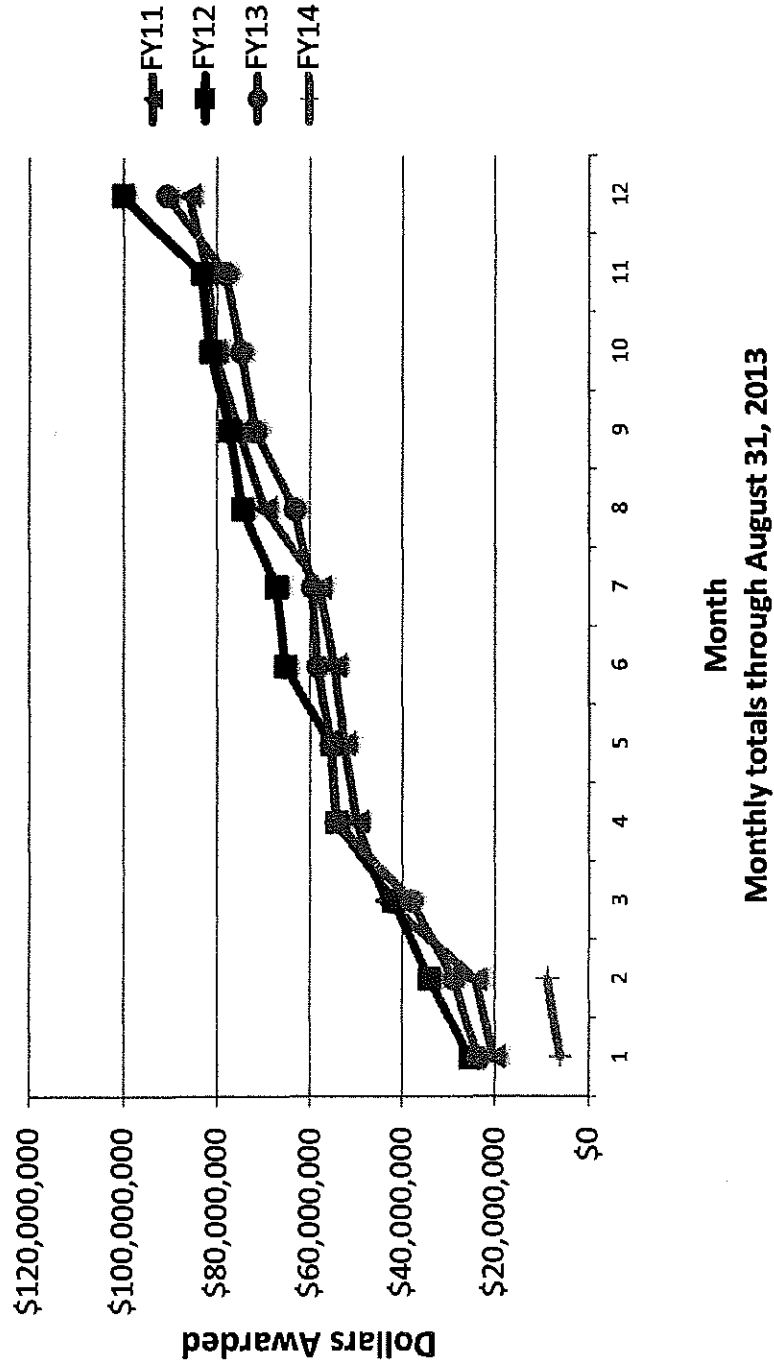

IX. REPORTS OF THE COMMITTEES OF THE BOARD

A. Academic Affairs Committee

Provost's Report

Dr. S. Narayanan, Provost, presented his report.

Two candidates being interviewed for the Associate Provost for Faculty and Staff Affairs position presented at open forums. A recommendation will be forthcoming in the next several weeks. The search for the Dean of the Graduate School is progressing with 40 candidates applying. The plan is to bring the candidates to campus the end of October. Dr. Narayanan commented on the Welcome Center and noted that the Board would be touring the new facility later that day.

Enrollment Update

Ms. Barbara Bullock, assistant vice president, Institutional Research, presented an enrollment update. In terms of revenue, 2 of our 3 semesters are in the books and tuition and fees are performing slightly better than the approved budget. She reported that 3,832 students graduated from Wright State this year, the second highest number in the university's history. The new direct from high school freshmen are coming in more prepared than ever with an average ACT of 22 and an average high school GPA of 3.2. Ms. Bullock stated that the Dayton Campus yield (which is the number of students enrolled divided by number admitted) of both new direct from high school and transfer students increased from last year. The direct from high school yield increased by 2% while and the transfer yield increased by 1%. The international student population increased by 41% and the Lake Campus degree-seeking students increase by 12%.

National Center for Medical Readiness (NCMR) Update

Dr. Robert Fyffe, vice president for Research, informed the Board that the National Center for Medical Readiness has a new director – retired General Rufus Smith. General Smith has met with many community partners and has prepared NCMR and the Calamityville site for elevated activity in the training of first responders and the integration of UAS activity (in conjunction with WSRI).

Funding for FY'13 is down because Wright State is no longer the fiscal agent for Ohio Link, and also as a result of the negative effects of the sequester and lack of state funding for research.

Dr. Fyffe reported that the first year of operation of the Clinical Trials & Research Alliance (CTRA) has been very successful. The leadership team, Dr. Art Pickoff, Mark Wysong and Loren Friedman, has initiated nine new trials and has the same number under negotiation, and a pipeline of two dozen more trials being evaluated.

Ms. Julie Carstens has been named the new director of compliance. She will oversee all university compliance areas.

Commercialization activity includes NSF I-Corps funding for the inventor and entrepreneur team leading creation of a start-up company around Dr. Sheth's inventions. Other in-house opportunities have emerged from the university's inaugural Technology Roundtable, and our Technology Transfer office is pursuing licensing contracts around these projects, including one developed by staff in the office for Environmental Health & Safety.

B. Finance and Audit Committee

Vice President's Report

Dr. Mark Polatajko, vice president, Business and Fiscal Affairs, reported on several activities that are currently underway within the Business & Fiscal Affairs Division.

FY14 YTD Budget Performance: Dr. Polatajko stated that the university is in the process of developing their budget re-forecast based upon actual activities realized from the first quarter of the fiscal year. In terms of revenue, 2 of our 3 semesters are in the books and tuition and fees are performing slightly better than approved budget (approx. \$2 million) due to the growth of the international student population (40.5% growth), improved new direct from HS yield (from 42 to 44%), and an increase in transfer students of 4.7%.

In addition, on the sales and services side, our guaranteed revenue from our newly introduced Hospitality Services initiative will yield an additional \$250,000 as compared to original budget, which had factored in a material increase based on data we had at that time.

In terms of expenses, the emphasis on resource optimization has provided significant cost savings and cost avoidance in fiscal year 2014 and beyond.

This balanced approach of generating new revenue streams and optimizing resources on the expense side of the budget truly represents our vision for the New Model for Funding Public Higher Education.

In summary, although there is 9 months left in this budget year, there are no indications at this time of any issues in not meeting the Board approved budget.

Hospitality Services: As previously noted, Wright State has successfully launched Hospitality Services at Wright State University, in partnership with Chartwells. As expected with any launch, we continue to fine-tune as we implement this transformational initiative. Dr. Polatajko introduced the Chartwells team, and stated that their leadership was appreciated and a privilege to partner with them in providing service to our students and community. The community will experience an exciting journey over the next year as a steady timeline of additional services comes on-line, such as Nutter Center Concessions and in-suite dining options; Tim Horton's; a fully licensed Starbucks in the Dunbar Library to replace the interim "Proudly Serving Starbucks"; the Raider Food Truck; and of course, the soon to come WOW Sports Grille in the Woods Commons in the Fall of 2015

Enterprise Print Management: Another exciting project that is currently underway is a shared services initiative for enterprise-managed print, in partnership with Central State University and Clark State Community College. Over the summer, a stakeholder-representative Committee developed & issued an RFP, reviewed and attended proposal presentations, and ultimately unanimously agreed to engage Xerox Corp. in developing a final total cost of operation/service proposal which is due at the end of October. A Letter of Intent was executed by all four parties in September to initiate the development of the final proposal and service offer for the consideration of all three partners. The Board will be kept apprised on the progress of this initiative, which exemplifies innovation

and entrepreneurship relative to leveraging the opportunity to partner with our peer institutions to deliver value to our stakeholders.

Healthcare Plan Re-sign: One of the largest components of the University budget is healthcare benefits – nearly \$30 million per year. Beginning with benefits year 2013, we launched a three-year strategy to proactively manage rising cost of healthcare through leadership, engagement, and challenging the status quo. The result of a collaborative effort and staying true to the following 4 guiding principles that guided this work will serve the University and its employees well into the future:

- ☐ Offer competitive healthcare benefits to retain and recruit top talent.
 - ☐ Promote behaviors that will support a healthy workforce thru wellness initiatives.
 - ☐ Ensure that healthcare benefits are affordable and accessible to all University employees.
 - ☐ Manage the university's healthcare costs in an effective manner in alignment with industry standards and best practices.
- Mr. Dennis Obyc and Mr. Pete Ugo from Crowe Horwath LLC reviewed and commented on the Annual Audit Status Update.
 - Mr. Rocky Doering, Fund Evaluation Group, went over some practices to enhance investment management.
 - Mr. Jeff Ulliman, assistant vice president and controller, shared the university's investment reports for June and August 2013.
 - Mr. Ulliman reviewed the university's expenditures of \$250,000 - \$499,999. No action was required. These reports have been distributed to the trustees and will be filed with the official Board of Trustees' records.

C. Student Affairs Committee

Vice President's Report

Dr. Dan Abrahamowicz, vice president for Student Affairs, discussed the recent "Job Fairs" hosted by Career Services. The three events allow students and employers to make those all-important first connections leading to internships and career placement. Over 177

companies attended the three events and interacted with 681 students looking in the fields of STEM, business, public services and creative arts.

Wright State's Homecoming celebration will be held the weekend of October 11th. A series of student events include a club football game, a men's soccer game, the "Chili Cook-Off" and a dance culminating in the crowning of the Homecoming King and Queen.

Mr. Ryan Rushing, student trustee, highlighted his efforts on behalf of students to introduce legislation amending the Ohio Public Employee Retirement System (OPERS). Currently students employed on campus are permitted to exempt from the state retirement system unless they are not enrolled in classes; in which case participation is mandatory. With the proposed change, students would be permitted to opt out of OPERS regardless of enrollment status saving students the 10% contribution rate and the department the mandatory 14% rate.

Changes in the Division of Student Affairs include Assistant Chief David Finnie assuming the role of interim chief of WSU Police and Ms. Katherine Myers being named interim director for Disability Services. A national search is underway for the director of Disability Services which is the first time in 40 years that a search is being conducted for that position.

1. Resolution – Jeffrey Vernooy

A resolution recognizing Mr. Jeffrey Vernooy for his 37 years of service to Wright State and his numerous achievements and lifetime contributions in the areas of student service and equal rights is as follows:

RESOLUTION 14-9

WHEREAS, Jeffrey Vernooy dedicated 37 years of his life to service at Wright State University and to meeting the needs of students with disabilities; and

WHEREAS, Jeffrey Vernooy demonstrated exemplary leadership skills in his role as Director of Disability Services; and

WHEREAS, Jeffrey Vernooy served with distinction as a champion for justice and civil rights; a leader in accessibility; and a mentor for fostering independence and finding the ability in ourselves, therefore be it

RESOLVED, that the Wright State University Board of Trustees recognizes the numerous achievements and lifetime contributions made by Jeffrey Vernooy.

Mr. Soin moved for approval. Mr. Bridges seconded, and the motion was unanimously approved by voice vote.

- **Student Government Report**

Ms. Rachel Fagan, Student Government vice president outlined the implementation of the 2013-2014 campaign platform issues including increased collaboration with student organizations, improved Student Government visibility, and fostering of new campus traditions. "Speak Out" sessions are planned for October to allow students to enable students to voice their issues and concerns. Student Government Senators also hope to connect with the 208 registered student organizations on a monthly basis.

Mr. Sukhman Singh, Student Government president discussed "Raiderthon"; Wright State's first dance marathon planned for November 16, 2013. A goal has been set to raise \$50K for Dayton Children's Hospital Miracle Network with \$19K pledged to date.

- **Updates**

Mr. Dan Bertso, director of Residence Life and Housing, shared highlights of Wright State's 20th annual "Move-In Day". Over 300 student and 200 faculty and staff volunteers moved in 1,200 families in the space of six hours.

New initiatives for next year in residential housing are focused on Learning Communities (LC). The Hamilton Hall Engineering LC will be expanded to serve all STEM disciplines by incorporating the classroom space in the lower level. Other plans include a partnership with the College of Business to support business majors, the creation of transfer students clusters, and the revival of the "Career Floor" focused on identifying best fit between students and their career paths.

Other topics of interest included the status of the Woods Commons project and the opening of the Campus Ministry building. The Commons project is slated for completion in Fall 2015. The Campus Ministry building was honored as the recipient of the "Excellence in Architectural Design" award by the American Institute of Architects.

Ms. Lydell Perry, community director for College Park, reviewed the extensive training process 62 RA's underwent prior to classes beginning. Topics covered included university policies and procedures, campus resources, student

engagement and development theory and conflict management. Ms. Jessica Ohler, 4th year RA, also discussed the specialized “Behind Closed Doors” training that utilized role playing to prepare RA’s for the unique challenges of their positions.

The theme of this year’s R.A. training; “Do You Believe in Magic”, was highlighted by Mr. Christopher Hayes, third year RA. Residential assistants bring “magic” to their communities by providing the best campus living environment possible.

Ms. Katherine Myers, interim director for Disability Services and Mr. Jason Gepperth, ability advisor discussed Wright State’s Ohio’s STEM Ability Alliance (OSAA) program. Funded by a National Science Foundation grant and supported by the Ohio Board of Regents, the program encourages students with disabilities to choose STEM majors and while preparing students for employment in STEM related jobs. OSAA incorporates academic support, coaching, peer mentoring and learning communities to enhance student success.

OSAA currently is serving 120 students with disabilities. Based on measurements of retention and persistence, OSAA students had high retention and graduation rates in comparison to national averages.

Ms. Jennifer Border, a Ph.D. candidate majoring in Human Factors Psychology, reflected on her experience with OSAA. Ms. Border credits the program for enhancing her success.

D. Student Trustees’ Report

Ms. Tiffany Fridley, student trustee, reported on the following items:

Fall Feast was held on campus August 30th with 208 organizations participating in conveying to the students what is available on campus and how to get involved and participate.

The Air Force 5K was scheduled for Friday, September 20 – while the event was cancelled due to Rain, students were readily available and ready to help.

This past week we have featured the tunnel of oppression was featured here on campus. This is an opportunity for us to educate our campus and the incoming students mostly about the different forms of acceptance and oppression that we expect and hope our student will embody when they participate in events and leave our campus.

Beyond that our students are excited about the campus expansion,

although they are nervous about all of the construction that is going to happen; they are excited for all of the spaces.

Homecoming weekend has events coming up, and the goal is to help increase the connections between the current students and the alumni, so making the homecoming events more visible on campus, and encouraging students to go out and connect with the alumni that are able to come back for that weekend.

One of our endeavors is that Mr. Rushing and I would like to highlight is some of our smaller organizations that are on campus this year. One of the smaller programs within the area is the Scuba program. One of the recent opportunities that has been recognized in the region as an integral part for the forensic dive team that has been out doing dive recovery for the missing Erica Baker who went missing 14 ½ years ago and people from the dive program have been given the opportunity to be a part of that dive team.

Ms. Fridley is currently working on reviewing the requirements and expectations of some of the masters programs being offered on campus to be sure that Wright State remains competitive with other programs, not only across the state, but within the country. This is to insure that our graduates are going out there with the best possible education and to succeed.

The student trustees across the state are working to form an organization to keep all student trustees connected so that they can keep up to date on other events and happenings within the state.

E. Faculty President's Report

Dr. Dan Krane reported on the following:

Voting recently concluded on the new Constitution and By-laws with the following results: 176 in favor, 10 opposed. Dr. Krane reported that this is a great testament to the team that they had in place to head up this endeavor.

Several new committees are being formed to assist with these attributes. There have been changes to the undergraduate curriculum and academic policies committee. Also the amount of time per term for the Faculty senator for one year terms with reelections occurring every year with no limit. Now the faculty senator will have a two-year term with a two term

limit. Matt Rizki will take over the Spring term. Provost Narayanan has approved these changes, so at this point this matter is closed. Wright State is represented on the Ohio Advisory Council with two representatives. Dr. Krane is one of the representatives and Dr. Rizki is the other acting in accordance with the Chancellor. Dr. Krane's top priority is to get more citizens to enjoy the benefits of higher education. He has been working with other members in order to accomplish this goal. One of the things he has done is to foster and build relations with Ohio's Inter-university Council. Dr. Hopkins is the Chair of that organization, and has been talking about ways to implement this into higher education. Dr. Hopkins and Dr. Krane are working on another piece that speaks to the importance of access to higher education and providing faculty input into matters of higher education that are decided at the state level.

The COLA hosts the ArtsGala that have raised over \$1.6M for scholarships. ArtsGala 2014 will be on April 12, 2014.

Stephen Schwartz, the First CELIA Visiting Artist was on campus March 18 and 19, 2013. He is an academy award winning lyricist and musician with some hits like Wicked, Godspell, Pippin, Pocahontas, Price of Egypt to name a few.

College of Liberal Arts also offers excellent internship programs - US Marshals Service, US Secret Service, Greene County Sheriff Office to name a few.



Review

In the past two years, the office of alumni relations and the Alumni Association completed a new strategic plan. The results thus far include doubling the number of our alumni networks and active alumni volunteers. We currently have 17 alumni networks and over 225 alumni volunteers.

We did a complete overhaul of our website, which resulted in many more visitors and more time spent enjoying content. We have doubled the number of email newsletters we send and worked with the colleges to send alumni newsletters on their behalf. We have implemented a tracking system for all email being sent to alumni to ensure we aren't sending multiple messages on the same day. We've quadrupled our Twitter followers and doubled our Facebook and LinkedIn followers, in addition to more than doubling our engagement of those followers.

We've seen an increase of nearly 400% in alumni donations towards Association sponsored scholarships (\$12k-\$46k). Nearly one half of our alumni networks are working on developing scholarships representing their affinity or region. Alumni now represent over 18% of the roughly \$80 million campaign total to date compared to less than 5% in the last campaign.

We've implemented new events such as Alumni College, Family Programming, Alumni Tours and Senior Week, which have engaged completely new audiences. We purposely identified segments of our alumni population we were not successfully engaging and targeted them with this new programming. We've revamped successful events and gotten rid of events that didn't pertain to our mission.

We embarked on a print and online alumni directory project that updated tens of thousands of alumni records and gave us more accurate information. We've started tracking alumni activity in detail so we can measure the engagement of each individual. This helps us more effectively target alumni for volunteers, awards, and gift prospects.

We have brought in more revenue from corporate partners than any time in the past decade. We have stemmed the financial crisis of the Association through budget cuts and increased revenue, which has resulted in financial solvency.

Future

The next year will bring about big changes in the model of how we engage alumni, with more emphasis on broad base engagement. This is all in preparation for the public phase of the campaign, set to kick off in the fall of 2014. We will continue to engage more alumni and different audiences through inventive communication and programming.

For the third time in the last four years, the Foundation's investment returns exceeded target returns. With respect to our endowment portfolio, the investment return for FY13 was a positive 10.4%, slightly below the benchmark return of 10.5%. Five-year and since-inception returns exceeded their composite benchmark returns by sixty and twenty basis points, respectively. The endowment portfolio finished the year with a market value of \$72.6 million. Our total investment value at year end, including non-endowed portfolios exceeded \$107 million, close to the highest value we have ever recorded. Investment earnings added a net \$9.4 million in value to the portfolios in FY13. The highest performing asset classes during the year were U.S. equities (+21.7%), structured credit (+21.3%) and global equity ex-US (+16.6%).

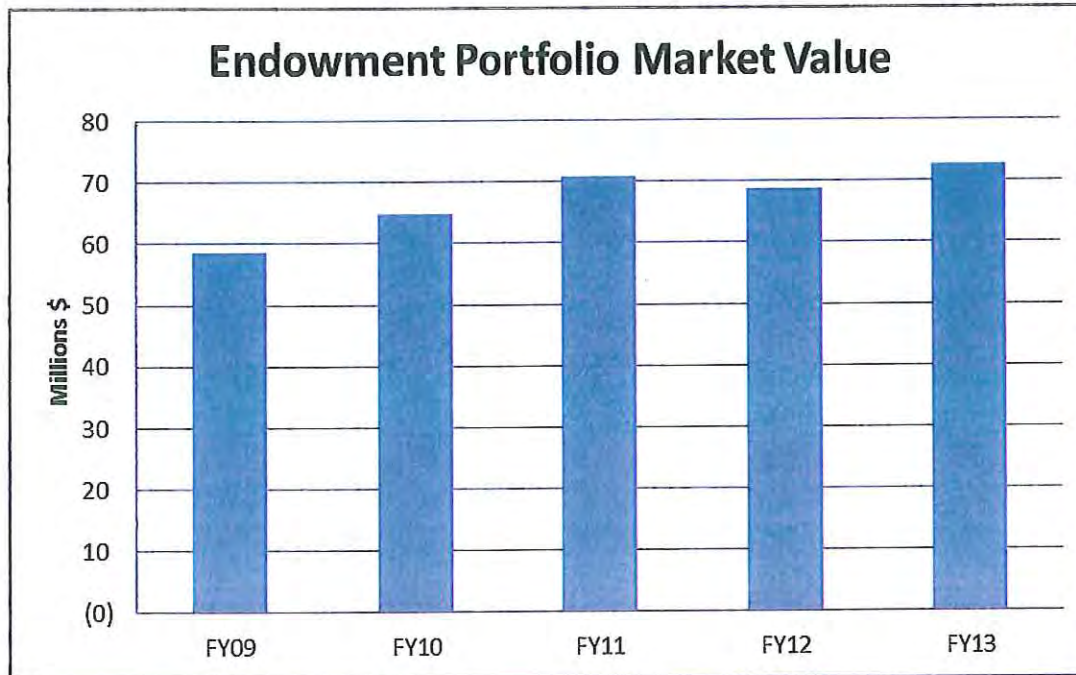
The Foundation's portfolios were rebalanced during FY13 and allocations remained within tolerances established by our investment policy statement. Our hedge fund allocation (13% of the endowment portfolio) is now divided between two "fund of funds" products, one slightly more aggressive than the other in terms of return pursuit. Our private equity investment is now 54% funded and is generating positive returns for the endowment portfolio. The structured credit investment, while no longer providing the spectacular returns that it did a couple of years ago, nevertheless continues to be a star performer within the endowment portfolio.

The Foundation's current endowment target allocation, actual allocation and market values as of June 30, 2013, are presented below:

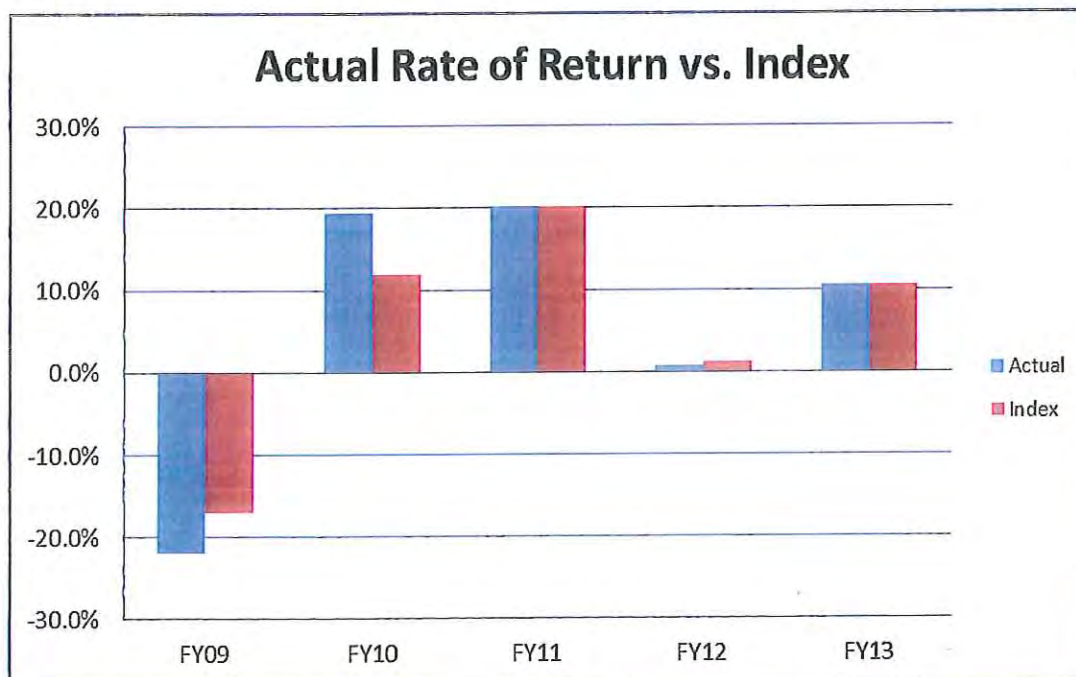

Endowment Value

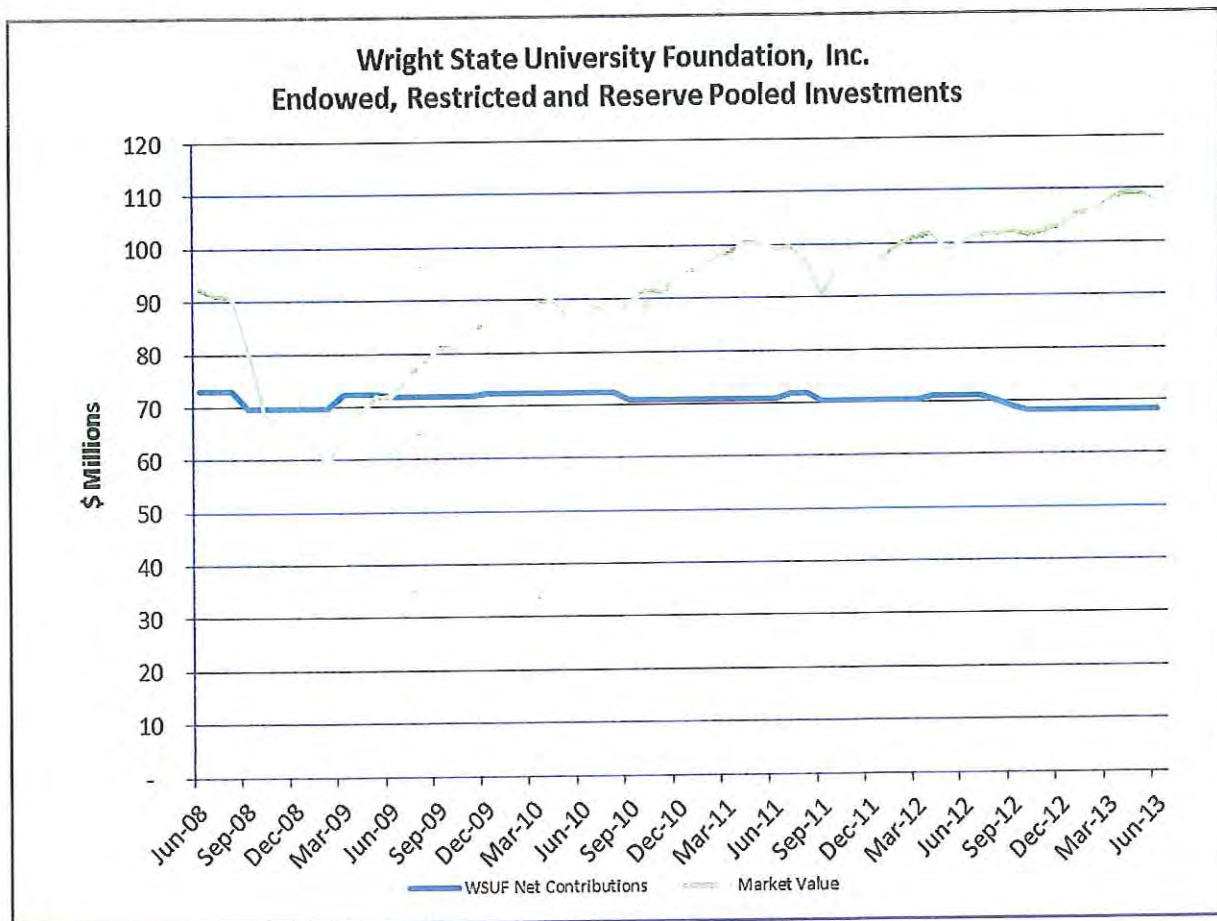


Endowment Historical Rates of Return

Planned Giving Update

FY13 Results:

We finished the Fiscal Year with 19 new planned gifts with total known value \$4,630,308. Two planned gifts were charitable gift annuities (\$150,000). One was a new donor-purchased/ Foundation-owned life insurance policy (\$150,000 face value). The remainder were bequest intentions or beneficiary designations.

Proceeds from two realized bequests totaled \$101,000. Two charitable gift annuities and one charitable remainder trust were terminated. The value of the residual funds was \$319,778.

Among the 19 planned gifts were two more \$1 million and higher bequest intentions from Wright State alumni.

As of 9/10/13, there are 13 planned gifts in discussion with a known or estimated value of \$9.5 million. There are 19 additional possible planned gifts in the early stages of discussion (with gift values yet to be determined).

Annual Giving Update

Campus Scholarship & Innovation Campaign (CSIC) (*Wright State's Faculty, Staff, and Retiree Campaign*)

The 2013 CSIC Campaign, "CSI: Wright State" has raised \$484,105 to date. Contributions from faculty, staff, and retirees will continue to be tracked until December 31, 2013, and will count toward this year's campaign. To date, 54% of full-time faculty and staff participated during the 2013 campaign. This is a new record for Wright State, which surpasses last year's participation rate of 50%.

Direct Mail/eSolicitation

The 2013 Spring Appeal raised \$68,314, the most amount of money generated by Spring Appeal. The appeal had a 5% response rate, which is higher than the typical 1% response rate associated with direct mail appeals. Spring Appeal included customized return address labels and included a special "thank you" segment to individuals who already gave during this fiscal year.

Phonathon

Wright State has initiated a partnership with Wilson-Bennett Technology to manage two seasonal phonathon campaigns. This partnership is expected to increase gift revenue from the phonathon by improving solicitation strategies, cleansing the data for more accurate contact information, maintaining a highly qualified phonathon manager, and assigning more callers per night.

The new phonathon location was prepared in the Foundation Building and has space for 20 callers per night (increased from 15). The Fall Campaign began on Saturday, September 7 and will run for seven weeks.

Student Development Officer (SDO)

The Student Development Officer program has expanded from one to eight with students representing the Graduate School, COLA, RSCOB, SOPP, COSM, and CECS. Prospects were assigned to each SDO based on the student/alumni major and college. Strategically, these students will attempt to build a relationship with alumni giving prospects through multi-media channels (print, electronic, and phone) and attempt to increase annual giving donors and dollars while building a relationship that is more personal than possible with the Phonathon.

Student Discovery Initiative

The Student Discovery Initiative is a partnership between Student Affairs and University Advancement designed to have students make “discovery” visits with Wright State Alumni. Students assigned to this initiative will be provided a list of prospects that are believed to have the potential to become major prospects in the future. Students will contact these prospects during their own time and will schedule appointments to meet with them and talk about Wright State. Students will bring Wright State materials to share with the prospects and in turn will learn more about the alum they are visiting. Students will capture updated contact, employer, and family information and will be encouraged to share how Wright State has impacted their lives.

Woods Commons. The Program of Requirements is in the final stages. Advertisement for architects will be posted by the end of September 2013.

Welcome Center. The ribbon cutting for the Welcome Center, which includes Admissions and Raider Connect, was held September 4, 2013 and well attended by the campus community.

Creative Arts Center. Champlin was selected as the project architect. Construction Manager at Risk (CMR) firms have been shortlisted and final selection will be made by the end of September.

White Hall. Construction is complete and the BSOM Skills Assessment Training group have taken occupancy, returning to campus after having previously been located off-site.

Dicke Balcony. Design has been approved for additional faculty space and HVAC renovations. Construction will take place during Fall Semester with occupancy expected by December 2013.

St. John Bosco Chapel. The St. John Bosco Chapel, also known as the Campus Ministry Building, has been selected as a 2013 American Institute of Architects Award Winner for Excellence in Design.

House Bill 7 Initiatives. ABM has completed 16 energy conservation measures (ECMS), with another 20 currently underway.

Design Standards. The University Design Standards are completed and ready to publish pending minor Wright Way Policy changes to support the documents. The Design Standards will be available online.

Lake Campus New Academic Building. The Lake Campus Dean is working with McGill Smith Punshon on the program of requirements for a new academic building, expected to be completed by November 2013.

Allyn Hall Accessible Restroom and Vending Lounge. The vending lounge in Allyn Hall was renovated for inclusive ADA design, with the addition of an accessible family restroom and countertop workspace. The lounge opened for use in August 2013.

Student Union 2nd Floor. The Program of Requirements is underway for the Student Union 2nd floor, planned to include student services such as the University Center for International Education, the Graduate School, and Wright State International Gateway.

Kettering Center. The City of Dayton and Wright State have submitted a grant application for asbestos remediation funding and is awaiting response.

Communications & Marketing Report

Chancellor's visit

When Wright State rolled out the welcome mat for new Ohio Chancellor John Carey July 29 as part of his statewide budget tour, Communications and Marketing prepared a glossy printed piece for the event. The magazine, entitled *Wright State University RELENTLESS as presented to Chancellor John Carey*, was developed specifically for the chancellor, but the 2013 highlights publication was well enough received that a larger press run is being prepared for multiple future uses. The magazine featured articles about the mission of the Aerospace Professional Development Center (APDC) at Wright State; getting Wright State students to the finish line; a feature about disability services; another about WSU graduates in key positions at the Air Forces Research Institute at Wright Patterson AFB; the university's involvement with the Dayton Regional STEM School from its 2007 start-up operations through today; how computer science researchers at Wright State have aided flood victims worldwide; and the benefits of business partnerships WSU has formed, featuring a long-running success story with Speedway. Also, an insert of 13 significant news features--all part of 2013 coverage for the university--was included in the booklet.

2013 Convocation. Outdoor billboard plans

Behind the scenes in preparation for this fall semester's annual University Convocation in the Apollo Room, the Communications and Marketing social media team, which is a sub-unit of two staffers, worked with President Hopkins to prepare his Twitter account for the Freshman Convocation and University Convocation audiences. The president's (@PresidentDHOP) initial tweet came during the freshman event, a raucous response from the new students followed, and since then, many students have been tweeting their thoughts to Dr. Hopkins. The president's online tweeting (see <https://twitter.com/PresidentDHOP>) has become a regular communications post of the university with the result being that hundreds of tweets have been communicated to the president, mostly from students and parents. At University Convocation, a number of those tweets were used as part of a video backdrop for the president's public address.

The use of the hashtag symbol (#) followed by a key word and popularized by Twitter account users will be utilized in an outdoor signage campaign that will target potential students. The first billboard in the series will feature the hash tagged word #braggingwrights. Followers of #braggingwrights will find related tweets on Twitter by searching #braggingwrights. There, they will learn about the many items Wright State has to brag about.

We've moved

The 27-person communications and marketing staff has moved off the main campus, just one mile down Col. Glenn Highway to remodeled executive offices in the 4035 Building, 3rd floor. The unit's new address is 4035 Col. Glenn, Beavercreek 45431. Communications and Marketing shares the building with the Wright State Research Institute in the office complex commonly referred to as Signal Hill. Plans are being finalized for an open house for all communications and marketing clients and constituents, to be held in October, date and time to be determined.

Projects

As preparations continue for fall's Strategic Plan celebration and five-year review Oct. 18, other projects that are in the works include:

- Video features honoring 12 faculty and 10 staff members for their work as part of the 2013 Awards for Excellence for faculty and staff. All 22 feature videos can be viewed online at wright.edu/newsroom.
- The web team has rolled out more new sites on wright.edu, including the College of Science and Math and Disability Services.
- A communications and marketing team traveled to Columbus to study the Value City Arena at the Jerome A. Schottenstein Center in order to audit the indoor graphic design and themes there. A plan is in place to improve the interior appearance in the Wright State University Nutter Center.
- Communications and Marketing is finalizing in a report the successes of the unit over the past five years as part of the Strategic Plan event in October. The unit also is assisting other units on campus to aide their efforts in preparing five years of success stories.
- Working with Enrollment Management to support its marketing efforts for 2013-14, Communications and Marketing set a series of meetings with deans for engineering, liberal arts, business, and science & math in order to gain input from each unit and assist their student recruitment marketing efforts. Communications and Marketing and Enrollment Management met with Dean Bonnie Mathias to plan the Lake Campus marketing needs for the year.
- Working with purchasing, Communications and Marketing has received responses from 18 market research firms as part of the university's ITN (Invitation to Negotiate) for market research services. The formation of a committee comprised of on-campus and off-campus stakeholders will occur in the weeks ahead to study final market research proposals. Firms qualifying for presentations have a deadline of later this month to submit their written proposals to Wright State's purchasing department.

Enrollment Management Report
September 20, 2013

1. Undergraduate Admissions/Recruitment/Enrollment Marketing

- A Raider Open House was held on August 2nd with over 600 attending. This was an increase of more than 100 students over last year.
- A New Transfer Open House was held on August 8th with 64 transfer students attending.
- On August 5 the Office of Undergraduate Admissions moved into their dedicated new space in the Student Union that will serve as a gateway to the university. The new space features a 50-seat presentation room with an 80" touchscreen to accommodate daily tours. The space also features artwork and iPads that will help to tell the Wright State story and the success of our many graduates.

2. Financial Aid

- The Office of Financial Aid is collaborating with Institutional Research, Dr. Xinhui Zhang (CECS), and Ms. Bev Grunden of the Statistical Consulting Center to investigate new ways to leverage institutional financial aid resources. It is anticipated that a new academic merit scholarship program will be developed for use during the recruitment of the fall 2015 class of new, direct from high school students. Smaller, more focused programs will also be introduced and used for the recruitment of the fall 2014 class.
- Ms. Cathy Bussen (Associate Director of Scholarships & Financial Aid) is working with the Office of Institutional Advancement on a new scholarship application process, called Scholarship Manager. This new program will allow students to more easily apply for Foundation and university scholarship programs and allow scholarship committees to make recommendations more efficiently. Scholarship Manager is set to "go live" for scholarship applicants yet this year.

3. College Readiness

- Wright State University is currently partnering with several high schools on a College Readiness initiative:
 - Dayton Public Schools
 - Jefferson Township High School, Dayton, Ohio
 - Springfield High School, Springfield, Ohio
 - Memorial High School, St. Mary's, Ohio
 - Fairborn High School, Fairborn, Ohio
- The College Readiness program delivers content to high school students regarding academic enrichment, non-cognitive skill building, financial aid/literacy, the college application process and cultural enrichment where applicable.

4. RaiderConnect

- Opening in its new permanent location at the front of the Student Union on July 29, RaiderConnect provided enrollment services (aided by the implementation of queuing software) for walk-in visitors for the first Fall Semester start since its inception.
- During the last two weeks of August 2013, the 12 RaiderConnect staff assisted students as follows:

Diversity Data

Preliminary enrollment data for fall 2013 indicates that we have a significant, welcome increase in international students. In contrast we continue to see a decrease in American minority students, particularly African-American students, as a percent of our incoming class. Once the enrollment data for fall 2013 is finalized, specific numbers related to these trends will be shared.

Personnel Changes

I am pleased to announce the appointment of Matthew Boaz as the Director of Equity and Inclusion (formerly Affirmative Action) effective September 16, 2013. Mr. Boaz most recently served as the director of the Office of Equal Opportunity and Access at the University of Cincinnati. Prior to his arrival at Cincinnati, he served as the Assistant Vice President of Institutional Diversity and the Director of the Office of Equity and Equal Opportunity at Miami University in Oxford, Ohio. Matthew has also worked as a Compliance Officer in both Baltimore and Pittsburgh for the U.S. Department of Labor, Office of Contract Compliance Programs. He is a member of the American Association for Affirmative Action (Quad-A) and the Columbus-Dayton-Cincinnati Industry Liaison Group (CDC ILG). He is a graduate of Bowling Green State University with a B.A. in ethnic studies and interpersonal communication, along with an M.P.A. in public administration.

Mr. Tony Ortiz, former lecturer in Kinesiology at WSU and the Governor's Latino Community Liaison, has been appointed Interim Assistant Vice President for Multicultural Affairs & Community Engagement. A national search will be conducted beginning later this fall to fill the position on a permanent basis.

Programs and Events

The following are highlights from a sample of the array of cultural programming conducted by the division.

Hispanic History Month Programming: A number of programs are planned to celebrate Hispanic culture on the WSU campus between September 15 and October 15, 2013. The first speaker on September 12 was Dr. Lilia Fernandez, Associate Professor, Department of History, at The Ohio State University. She presented a lecture entitled: The "New" Immigrants? Understanding Contemporary Latino/Immigration in Historical Perspective. When we discuss contemporary immigration, we generally think of people coming from Latin America and we consider them to be both "new" to the U.S. and "different" from immigrants of the past. In particular, we tend to focus on the legal status of immigrants today. How is immigration new and different today than in the past? How have our policies changed over the past century? How might we understand Latinos/as people who are "new Americans" but also have centuries of history in this country? Dr. Fernandez led a discussion regarding how we might reframe this issue. The discussion around her lecture was engaging and well attended.

Hispanic History Month activities begin in earnest with the ¡La Fiesta! Hispanic Heritage Month Kick-off program. Participants will experience Latino music and culinary dishes, salsa & meringue lessons, games, cultural booths, vendors, arts, crafts, and much more.

The WSU Women's Center in collaboration with the Center for Teaching and Learning (CTL) hosted a **mentoring reception for new women faculty** on August 20. It took place immediately after new faculty orientation. The Vice President for Multicultural Affairs & Community Engagement also gave a welcome and overview of programs and services provided by the division to new faculty. She also conducted a session on how understanding student identity development issues can enhance their teaching and student learning.

The Bolinga Center in collaboration with University College is conducting a **series of reading circles and discussions** about the First Year experience common text, *The Other Wes Moore*. The Ujima Mentoring Community is a pilot program coordinated by the Center that links work study in offices across campus with mentoring. The Center also continues to provide supplemental advising and referral with payment for tutoring to promote student success and diminish the academic achievement gap.

The office of Pre-College programs recently wrapped up a summer of successful camps and college preparedness programs. The Upward Bound program, a federal grant program designed to prepare low income students who would be the first to attend post-secondary education for college, culminated its summer enrichment activities with a college tour trip to Virginia Beach. **The summer camps and institutes served 1,354 young people. The Upward Bound summer program served an additional 40 students.**

The Vice President for Multicultural Affairs & Community Engagement will **lead a discussion of the book *Soul of a Citizen: Living with Conviction in Challenging Times*** by Paul Rogat Loeb on Monday, September 16. The program is collaboration between CTL and the Office of Service Learning and Civic Engagement. Informed by lifelong participation in peace, justice and environmental causes, Loeb offers new vision for personal engagement with societal issues and argues for a return to community involvement and social activism, which, he says, have declined since the 1960s and 70s. He points to increased social isolation and the widening opportunity gap between rich and poor and emphasizes the importance of the human connection. Believing that personal stories, not politics, capture peoples' attention, Loeb weaves in inspiring examples of effective activism and of heroism in ordinary people (adapted from *Publishers' Weekly*).

At last review of registrations, 246 educators, business people and community members had signed up to attend the Diversity in Multicultural Millennium (MM13) conference. At this rate we are expecting record breaking attendance when compared to other conferences of this nature held on campus. The conference will provide another opportunity to explore efforts related to justice seeking. The theme for this year's conference is Affirmative Action: 52 Years of Debate. It will take place on October 3-4. The conference will feature inspirational nationally renowned speakers as well as presenters from around the state addressing ways that they have acted affirmatively and proactively to promote equity and inclusion. Training and Committees

In collaboration with the University Center for International Education (UCIE) we will be hosting **several brown bag discussions on ways to promote international student success** to capitalize on the increase we are seeing in the number of international student attending WSU. Our first meeting will address "Cross Cultural Communication in the Classroom" and will take place September 24, 2013. It will be a casual discussion of how different cultures address classroom etiquette and communication, and how that influences student-instructor relations in the U.S. A small panel comprised of Wright State faculty and international students will be on hand to share their experiences and participate in an open discussion with all who attend.

Another critical initiative for which the VP MACE has been asked to provide leadership is the University's bid for the **Carnegie Classification of Community Engagement**. In addition to providing national recognition for our efforts, this process creates an opportunity for the campus to undertake systematic self-assessment and quality improvement related to our community engagement efforts. We have invited Grace Ramos to represent the Board on this important committee.

A committee has been formed to develop a comprehensive campus climate survey to be administered every other year to monitor our progress on creating an inclusive campus. The director of the Women's Center and the chair of the department of Management and International Business are co-chairing a committee to develop recommendations for campus, related to preventing gender-based violence, harassment and Title IX violations. There is representation from constituencies from across campus serving on the committee.

The division is pleased to share that the faculty union, AAUP-WSU, has endorsed training for search committees which includes information to help ensure equal opportunity, prevent the effects of implicit bias, and increase the diversity of employees with the following statement: *AAUP-WSU endorses the training of search committee members, and we encourage Bargaining Unit Faculty serving on search committees to participate in this training. We do so because, first, there is real benefit to us all in having a diverse community of scholars in which to work, teach, and learn; and second, because it is important for our University to adhere to its own non-discriminatory hiring policies not to mention applicable laws.*

The division will be continuing some of their programs that were well received by the university community during the last academic year such as the Inclusion Infusion grant program, the Social Entrepreneurship Fund and listening sessions for students, faculty and staff. Research and Sponsored Programs/Vice President for Research

Report to Board of Trustees, September 2013

Summary of FY 2013 Sponsored Grants and Contracts (attached).

Awards have declined, across the board, in the face of the government sequester and diminished state funding for research. Notable achievements in the past year have included competitive renewal, for a further five years, of the NIH Program Project Grant Award for neuroscience research under the direction of Dr Timothy Cope, director of the Wright State University-Premier Health Partners Neuroscience Institute. Despite severe challenges our research faculty members have successfully secured major grants from the National Science Foundation, the Department of Defense, and the National Institutes of Health, for projects ranging from cancer research to sensor development, and all faculty should be commended for their perseverance as well as their remarkable discoveries over the last year.

Clinical Trials and Research Alliance (CTRA).

In the first year, the CTRA initiative has already secured eight new clinical trials (~\$1.4M) and has more than two dozen additional opportunities under negotiation or in the pipeline.

National Center for Medical Readiness (NCMR)/Calamityville.

We are pleased to announce the appointment of Brigadier General (US Army, Retired) Rufus Smith as director of NCMR. General Smith took up his new position on August 27, 2013.

Wright State Research Institute (WSRI).

We are pleased to recognize the new director of WSRI, Dr Jason Parker. Dr Parker took up his position in May 2013.

University Compliance Officer.

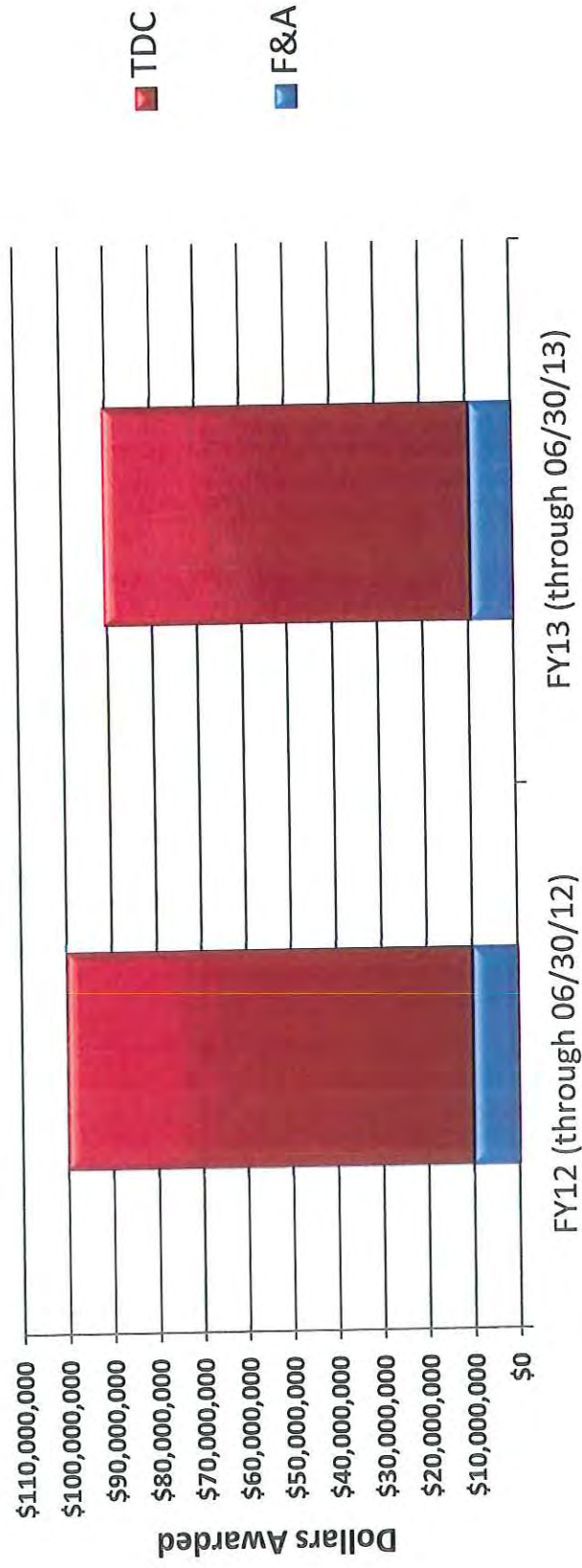
