- III. Doug Fecher, Board of Trustee's Committee Chair and Jeff Ulliman, Vice President and CFO met with the Senate Executive and Faculty Budget Priority Committees to discuss the Financial Governance Policy (Draft). Members of the committees were asked to provide their feedback on the policy no later than March 30. A second draft will be prepared mid-April, the final to be completed by June.
 - Concerns on how on how to keep students and the local communities informed on the status of the budget were discussed. A suggestion was made to speak with the administration about the creation of a website to keep the university and community apprised of the budget status.
- IV. The IT committee introduced Panopto Lecture Capture to the senators at the February meeting; Faculty Senate will vote on the adoption of the new software at the March 20 meeting. If approved, Tegrity's contact will run until the expiration date June 30. CaTS will save Tegrity recordings created through April 30; faculty may seek assistance from the CaTS department during the conversion process.
- V. Suggestions were discussed for the senate to write a resolution on the timely adoption of textbooks and to create a textbook and affordability committee. A recommendation was made to charge the Student Success Committee with the task of reducing the cost of textbooks. Faculty President Loranger will contact Tom Fenton, Chair of the Student Success Committee and Lukas Wenrick Student Government Association President to participate in the creation of the committee charge.

Senator Dan Krane will compose a Senate Resolution on the Timely Adoption of Textbooks and reach out to Mr. Wenrick to offer guidance in working with the Ohio Faculty Council on the Student Government Association's Textbook Resolution 17-04.
