a. Amanda Steele-Middleton stated that she will verify with admissions if the following line in the transfer policy is correct:

"Students with less than a 2.0 GPA who have been out of college for more than three years for not have to petition to transfer to WSU."

- b. The committee agreed that the 2017-18 UAPC should prioritize reconciling the Transfer Policy with the UG Admissions policy.
- c. When modifying the Dean's List policy, the committee discussed the creation of a "President's List"
- d. The committee agreed that the 2017-18 UAPC should re-examine the Fresh Start policy for additional changes other than the grading system updates.
- e. The committee feels that current practices may be in violation of Policy 3404 Required Advisor Approval for Registration, and that the 2017-18 UAPC should conduct further review.
- f. At the request of Carl Brun, who could not attend the meeting, the committee examined proposed changes to the Transfer Credit for Advanced Placement Policy however they were unsure of the language source and chose not to act until Dr. Brun can clarify.
