II. Old Business

- a. Staff Council Notes:
 - i. Bullying policy Lindsay Wight, (Office of Equity & Inclusion), wrote policy, using University of Wisconsin's bullying policy as model. Policy is being presented to councils, implementation expected by end of this fiscal year, 6/30/17. The policy includes a table specifying who to take complaints to, depending on the employment status of individuals involved, including faculty, staff, and students. This policy will be enforced.
 - ii. Discussion about the process and impact of Administrators returning to Faculty positions, including Professional Development Leave (PDL) aka Sabbatical.
 - iii. Discussion about faculty course release
 - iv. The Board of Trustees requested a negotiator from the state for the AAUP contract negotiations.

 - a. Before July 1, 2007, governed by Ohio Revised Code (or ORC)124.324

b. As of July 1, 2007, governed by 2006/2007 House Bill 187 Attachment - Civil Service Reform Bill (my highlights):

HB 187: ATTACHMENT

State Colleges and Universities, Counties and Municipalities, and Firefighters

State colleges and universities

- Eliminates DAS' authority and responsibility for auditing the human resource functions of statesupported colleges and universities.
- Grants the board of trustees of state-supported colleges and universities the authority to adopt rules
 to carry out human resources functions, but makes state-supported colleges and universities subject to
 DAS rules until such time as the board of trustees adopts such rules.
- Requires the Executive Director of the Inter-University Council to coordinate a committee that shall consult
 with DAS and develop guidelines that are to be used in adopting rules addressing, at a minimum,
 classification and compensation plans, recruitment, selection, appointments, performance, discipline
 and termination, layoff and reduction-in-workforce, paid leave, holiday leave, benefits, and appeals
 processes for the officers and employees of their college or university.
- Allows a state-supported college or university or municipal corporation to use services and facilities furnished by DAS that are necessary to provide and maintain payroll services and state merit standards, and requires that they pay the cost of the services and facilities that DAS furnishes.

c. Talking Points:

- i. Any possible changes to Bumping Rights should have been announced before the VRIP in summer 2016.
- ii. The only way to save money is to lay off more senior employees resulting in age discrimination
- iii. Classified employees' right to bump, i.e. more job security than unclassified staff, was held up as the reason for lower pay and less vacation for classified vs unclassified employees. To alter bumping rights immediately before a major layoff is deplorable.
- iv. If the University can pay temps every month, they should be able to find jobs for people who are being displaced.
