  - In the recent budget presentation, Walt Branson stated that 40 additional positions will be eliminated. Staff Council members requested that staff be notified as soon as possible.
  - Unified Staff CSAC hosted an open forum on 5/16; shared slides compiled by HR; and discussed potential changes to classified staff. CSAC reps stated that the majority of classified staff members present were opposed to the material presented. USAC supports vacation parity.
    - Steve Berberich stated that with his departure, at the end of June, his position will not be filled by then and that his duties will be divided.
      - Bill Rickert will be working part time on faculty issues.
      - Shari Mickey-Boggs was asked to serve as the administrative liaison with Staff Council; however, Adam shared Staff Council's concerns with this arrangement and said that he will take these concerns to President Schrader.
  - Office relocations Steve Berberich said that several office relocations were delayed due to austerity measures. These relocations are currently being completed. Council members shared concern of not knowing where departments/staff are located and that directories are not always current. Shari Mickey-Boggs said that it is up to the department heads and deans to communicate changes. Tom Fortner added that departments should update Mailroom and Shipping & Receiving when they move.
  - Dawn Banker shared concerns with Pre-College programs. Dawn said that several staff have reported that the supervision of the children is lacking – especially in the restrooms. Dr. Berberich said that he will take these safety concerns forward.
