WSRI/WSARC will adhere to the recommendations of the Office of Inspector General and address the concerns of faculty as noted in the Recommended Next Steps for WSRI/WSARC to Address Faculty Senate Resolutions. WSRI/WSARC will follow the timeline as stated and allow Faculty Senate to re-evaluate the objectives and shared metrics of each step identified in the document. Completion of this last step is expected January 2019 with an interim report due to Faculty Senate September 2018.
