The minutes of the February 2019 meeting were approved without dissent.

III. Report of the University President or Provost

Provost Report

Provost Edwards turned the floor over to Paul Carney who gave a brief enrollment update.

Enrollment update (Paul Carney)

- Direct from High School students
  - Expect a 6.8% decline over the next five years.
    - Overall number of Ohio High School graduates will continue to decrease in future years
  - Application yield % has decreased in four of the last six years.
  - The University needs to develop stronger relationships between students, faculty, and admissions staff.

- The scholarship challenge program in the Raj Sooin College of Business has been successful and similar programs could be implemented in other colleges.
- Transfer students
  - Enrollment of approximately 900 students per year
  - The University's goal is to reach 1500 students per year by 2023
  - The University needs to develop more partnerships, similar to the Wright Path Program, with area community colleges, and consider modes-of-instruction and course offerings that appeal to a wider range of non-traditional students
- Retention
  - The University needs to develop more methods to improve its 35% retention rate such as:
    - A proactive early alert system that allows faculty members and advisors to reach out to at risk students in a proactive way.
    - Capturing student attendance / participation during the first two weeks of the term
    - Some form of assessment measure during the first three weeks of the term.
    - Issuing of mid-term grades.
    - Formation of a retention support group to proactively address academic, discipline, and mental health issues.
      - Provost Edwards indicated that the early intervention team at her former institution was faculty driven and highly successful
- Current trends (as of February 2019) (Provost Edwards)
  - 9.6% decrease in total student enrollment
  - The University receives a lot of applications from low yield areas and very few applications from high yield areas.

### Provost Edwards

- The administration is currently working with Deans and unit heads to develop budget models and plans for the upcoming fiscal year and the next five years, and will conduct budget hearings with all unit heads during the month of April.
- Federal Aid regulations require universities to report on attendance during the first few weeks of each semester. The University previously incurred a \$2million fine for lack of reporting. Provost Edwards encouraged the Faculty Senate to develop policies or methods that would better facilitate the reporting of attendance during the initial weeks of each semester.
- Provost Edwards thanked everyone who was able to participate in the recent Open House for admitted students.

### Provost Report - Q&A

Senator Farmer expressed the need to develop a marketing plan and image change for the university. Provost Edwards indicated that she and Mr. Carney have been working with the marketing team and faculty from the marketing department on such a plan.

Senator Cebulash asked about the retention rate for transfer students. Mr. Carney could not provide an exact number without reference, but indicated that it is higher than the 35% overall retention rate.

Senator Cebulash then asked about what actions can be taken to improve direct from high school enrollment and how to compete with two-year community colleges. Mr. Carney indicated that the university has partnered with a high school advising software group used by high school counselors to help match students with colleges. In the past, the university would buy names of high school seniors which is typically a very low yield method. Additionally, the university should develop more competitive programs to bring students to campus to compete for scholarships.

Senator Carrafiello asked for clarification of the 35% retention rate quoted in the opening report. Mr. Carney indicated that the rate between freshman and sophomore years is about 65%. Wright State loses about 50% of the students between their sophomore-junior and junior-senior years.

Senator Carrafiello then expressed that the University used to have a robust set of learning communities that did not survive the last several years of austerity. Senator Abadie indicated that Modern Languages had to cut their immersion day for direct from high school students due to internal charges assessed by the university. Senator Rowley indicated that the national Science Olympiad, which brought 2000+ parents and students to campus, stopped using Wright State as a host due to similar reasons.

Senator Kawosa asked about a written comprehensive enrollment plan for the university. Mr. Carney indicated that he has been developing plans for each college which will help build the University plan from the ground up.

Senator Bright asked for clarification regarding the declining rate of Ohio high school graduates. Mr. Carney indicated that the total number of Ohio high school graduates per year has declined from over 200,000 several years ago to approximately 120,000 graduates per year.

Senator Greene expressed concerns regarding a few hurdles to healing the relationships between administration and faculty, including potentially incorrect comments made by university legal counsel about a faculty member during a recent SERB hearing; an HR seminar advertised to help foster open communication but did not offer any advice to that effect; and finally, as discussed at the March Senate meeting, the deletion and hiding of comments on Wright State social media pages. Provost Edwards indicated that she will follow-up with Craig Woolley regarding the social media issue.

Senator McGinley asked when CoLA faculty can expect a response to a recent no confidence vote, held by CoLA Faculty Senate (8 no confidence – 2 confidence), in the CoLA administration. Provost Edwards indicated that she has not received official notification of the vote.

Senator Wooley indicated that there are a lot of walls between administrators and faculty, and even between faculty members. All members of the University need to rise above bad behavior and be open and honest with each other in order to lead by example.

Senator Greene asked when the contract will be able to be reviewed by the Faculty. Provost Edwards indicated that it is her understanding that the drafts are currently being reviewed by both WSU-AAUP and the administration.

#### IV. Report of the Senate Executive Committee

##### A. Senate Election Results

Faculty President Doom thanked everyone who participated in the recent elections, and congratulated all of the successful candidates including Faculty President-elect Krane and Faculty Vice President-elect Luehrmann.

There was a need for additional runoff elections for the College of Liberal Arts and Boonshoft School of Medicine. [Addendum 3/26/2019: The CoLA runoff election was subsequently canceled due to Hope Jennings conceding the runoff and volunteering to assume a 1-year vacancy term to fill Dr. Luehrmann's vacated CoLA seat.]

Due to a ballot error, the CECS elections were invalidated prior to completion and will be re-launched at the same time as the runoff elections. (March 26 – April 5)

Senator Greene asked who brought the resolution forward and the motivation for the motion. Dr. Doom expressed that it was submitted by a non-Executive Committee Senator who wishes to remain anonymous; however, the Executive Committee made further edits to the original submissions so this version may not reflect the original author's intent.

A motion was made to add the Ombuds as the final step in the list of potential contacts in the second to last Resolved clause. The motion was seconded and approved without dissent.

Dr. Doom called the question to move this item as amended to Old Business at the April Senate meeting. The item was approved without dissent.

Senator Kawosa introduced the following language, submitted by a constituent, for Senators to consider amending the first paragraph after the 'Be it resolved' clause.

*Because Wright State University is committed to free and open inquiry in all matters, it guarantees all members of the University community the broadest possible latitude to speak, write, listen, challenge, **teach**, and learn. **No member of the Wright State community may limit these rights for any other member.** Except insofar as limitations on **these rights** are necessary to the functioning of the University, **all members** of the Wright State University community fully respect and support the freedom of all other members of the University community to discuss any **question, inside or outside the classroom.***

During discussions, the amendment was expanded to strike the phrase “when italicized”.

Senator McGinley expressed concerns that this resolution should include an educational aspect along with the restroom resolution, and that there may be conflict between the language of this resolution and the prior bullying resolution.

Dr. Doom called the question regarding the proposed amendment. The motion to amend failed. Dr. Doom requested that, should this item be approved for Old Business at the next meeting, that Senators submit proposed motions in advance in order to proceed in a timely fashion during the next meeting.

Senator Chamberlain expressed concerns that the final paragraph and associated references seem to point to Cleveland State policies and not Wright State policies. Dr. Krane expressed that the resolution does come from an original Cleveland State resolution and could benefit from additional edits to point to the corresponding Wright State policies. Dr. Krane further requested that this item be moved forward and the changes be made via motion at the next meeting.

A motion was made and seconded to send this item back to committee. The motion was approved with 1 nay. Dr. Doom asked Senators to send concerns and/or proposed changes directly to Dr. Krane.

Due to time constraints, after a presentation by and lengthy discussion with Senator Gallagher (GAPC Chair) and Dr. Barry Milligan (Interim Dean of the Graduate School), Dr. Doom encouraged all Senators to take this issue to their constituents and graduate committees, and to send feedback and proposed amendments to Dr. Gallagher and the Faculty Senate office in preparation for the April Faculty Senate meeting.

Dr. Doom called the question to move this item to Old Business at the April Senate meeting. A motion was then made and seconded to send this item back to committee. Dr. Gallagher expressed that the intent of the main language is to define the process by which Wright State collects the information and reviews it in a systematic way. Currently, the guidelines used are ad-hoc on a case by case basis. Dr. Gallagher recommended that the Senate move the item to Old Business and work between meetings to identify compromise amendments.

After additional discussions regarding whether or not to send this item back to committee, Dr. Doom called the question to send the item back to committee. After a voice vote, it could not be determined if the motion passed or failed. Dr. Doom requested a show of hands for approval of the motion; the motion failed with only 7 in favor of sending back to committee.
