- III. Dual Enrollment (3130) – the committee made edits to the current draft policy and Dr. Owens was charged with meeting with the CCP Director to review the edits prior to the next UAPC meeting.
- IV. CECS Admissions – the committee reviewed and approved two new program admissions for the College of Engineering and Computer Science. The policy update was forwarded to the Faculty President for inclusion of the February Senate Agenda Addendum.
