The University applies the housing fee to the student's account and subsequently reimburses Crawford Hoying using student fees received on account. The request for an increase to the original amount of \$5,683,563 stems from unexpected increases in Fall and Spring demand, plus higher than usual retention from Fall to Spring. Demand is a result of the rate change and the inclusion of Residence Life & Housing being included in the University's media advertising. Retention is also a result of the hard work of the Residence Life staff – Community Directors and Resident Assistants.
