# I. Call to Order

# A. AY2024-25 Roster

Faculty President Dawn Wooley called the meeting to order at 2:30 PM and turned the floor over to Faculty Vice President John Sherman to call the roll. Quorum requirements were met.

# II. Approval of Minutes

The minutes were approved as written.

# III. Report of the University President or Provost

The Provost addressed critical changes to the First-Year Seminar (FYS) program due to a shortage of faculty and course seats. The FYS program will change from a 3-credit course to a 1-credit course focusing on university-wide content with expanded options for who will instruct the courses:

- Planning on offering 44 sections of first year seminar next fall. 11 of those are three
  credit hour versions that are in the College of Liberal Arts where they're piloting a
  new course that combines one hour of student success with two hours of civics.
  Plus, they'll have four additional sections that are one credit hour UVC 1010 sections
  that are designed for undeclared students.
- Only 1,300 seats are available for fall 2024, but 2,500 are needed. (29 college-specific 3-credit sections + 11 pilot sections in COLA combining student success/civics). Moving from a 3-credit to a 1-credit course triples capacity.
- Reduced teaching loads and prior reliance on adjuncts/overloads left colleges unable to scale 3-credit FYS sections. COLA and CHEH face heavy adjunct hiring demands otherwise.
  - o Recovered hours range from 13.5 (CECS) 259 (COLA)
  - NTE teaching load hours adjusted down from 5-5 to 4-4 (24 credit hours)
- CHEH anticipates needing 725 seats or 29 sections if we maintain a three-hour course for first year seminar. This will require them between now and the start of the fall semester to hire 21 adjunct faculty to teach upper level courses so that they can shift the TET and NTE faculty to teach first year seminar.
- A 3-credit civics course becomes mandatory in 2026 due to Ohio Senate Bill 1, complicating future FYS structure. Transitioning to 1-credit FYS now allows flexibility to accommodate this.
- Registration for fall begins in one month, but college-specific content for 2-credit components remains underdeveloped.
- A 1-credit university-wide FYS model, revised by VP Amy Salazar, will focus on student success, career planning, and campus engagement. Faculty input is pending.

# **Q&A Summary:**

### **Senator Bennett:**

Question: Programs redesigned around 3-credit FYS face abrupt reversals. Concerned about logistical challenges for departments that restructured programs around 3-credit FYS.

Requests registrar support.

Response: Provost agreed to collaborate with the registrar to facilitate adjustments.

#### Senator Cebulash:

Question: Asked if the 1-credit model is permanent and how it aligns with workload policies.

Response: Likely permanent due to SB1; faculty could teach multiple 1-credit sections (e.g., three sections weekly) to meet workload.

### Senator Mejia-LaPerle:

Question: Asked about faculty involvement in redesigning the 1-credit course.

Response: VP Salazar is leading revisions; unclear if teaching faculty were consulted.

Provost Denniston committed to follow-up.

### Senator Stover:

Request: Asked for numerical data (e.g., seat gaps, adjunct needs) to be included in meeting minutes.

Response: Provost agreed.

Follow-up Question: Will online sections be available?

Response: Provost agreed to explore possibility with Registrar Lisa Runyan.

## Senator Yang:

Concerns: CECS faculty spent a year developing 3-credit FYS; proposed variable credits (1–3) by department. Argued some students benefit from college-specific content (e.g., exploring majors).

Response: Provost cited CECS faculty shortages but acknowledged cross-college flexibility. (e.g., COLA sections open to all).

## Senator Wischgoll:

Questions: (1) Whether curriculum changes comply with faculty governance policies; (2) Role of staff in teaching FYS.

Response: VP Salazar's content is a flexible "shell"; faculty retain control. Staff may teach FYS if faculty are unavailable.

### Senator Martin:

Question: Asked if sections remain college-specific.

Response: FYS will be university-wide to address uneven faculty capacity.

## Senator Rucker:

Question: Queried historical context (past FYS models) and rationale for revival. Followed up on public syllabus requirements.

Response: FYS changes aim to boost retention ( $64\% \rightarrow 75\%$ ); SB1 compliance (e.g., syllabivisibility) discussed later in the meeting.

Senator Steele-Johnson:

Question: Asked if departments can still offer 1–2 credit major-specific seminars. Response: Confirmed and encouraged colleges to supplement FYS with discipline-specific courses outside the core.

Faculty President Wooley indicated that the Executive Committee and other committees will collaborate on revised FYS-related policies.

# C. Policy 3520 – Repeat Policy

Summary of current policy and proposed changes (L. Runyan)

- Current Policy:
  - Students can repeat any course, regardless of prior grade (even an A).
  - Five-course forgiveness: Only the most recent grade counts toward GPA, even if lower.
  - Advisors flag students repeating A/B/C grades to ensure informed decisions.
  - Financial aid allows unlimited repeats for failed courses (F) but only one repeat after passing (even with a D).

# Proposed Change:

- Adjusts how repeats beyond five are handled (likely shifting from averaging grades to forgiving more attempts).
- o Goal: Improve retention/GPA by reducing penalties for repeated courses.

# **Q&A Summary**

- Senator Rucker: Do students need to earn a B or lower to repeat? Why would someone repeat an A?
- Response
  - No systemic restrictions: Students can repeat any grade, including an A.
  - Reports are sent to advisors to counsel students on the risks of repeating high grades. In practice, students mostly repeat D/F grades to meet program requirements.
- Senator Evans highlighted the nursing program exemption (stricter repeat rules due to accreditation) and raised concerns about advisor workload and students "falling through the cracks" without guidance.
- Response
  - The policy sets a university-wide minimum; programs like Nursing can enforce higher standards.

- Financial aid rules are unchanged; policy won't incentivize more repeats. Reiterated advisor monitoring but acknowledged advising challenges.
- Senator Wischgoll asked if allowing repeats actually help students graduate, or just delay struggles and cited a student who passed via COVID-era repeats but struggled in advanced courses.
- Response
  - Registrar acknowledged concerns but stressed students generally avoid repeats unless necessary. Emphasized policy autonomy: "We don't stop repeats, nor do most institutions."
- Senator Yang shared the following objections from the CECS curriculum committee:
  - o Frequent repeats signal students might be in the wrong major.
  - Repeats cost students extra time/money.
  - o High-demand courses face seat shortages.
- Response:
  - The Registrar reiterated that programs can set stricter limits if needed.
- Senator Rucker sought clarification to concerns regarding limits.
  - Response: Even with limits, students can enroll in the course elsewhere and transfer it back to WSU.
- UAPC Chair Owens added that a 2019 working group found that repeats could delay graduation but are often unavoidable.

After discussions, no motions were made from the floor. Faculty President Wooley indicated that seeing no motions she would move to table. No seconds or additional motion were made. [Note: In consultation with Parliamentarian Spirek, it was determined that this item will remain as Old Business given there was no vote to table the item.]
