Undergraduate Admissions

3110 Undergraduate Degree Seeking Admissions [date of last review/revision 2022]

In 2022, the UAPC proposed amending this policy to address (1) recommendations of the 2019 Senate Subcommittee to make the ACT/SAT test optional, (2) To incorporate and update based on IPEDS definition of a transfer student and (3) To revise regulations regarding international student English language proficiency requirements. These amendments were postponed pending a review by the VP of Enrollment Management.

3120 Undergraduate Non-Degree Seeking Admissions [date of last review/revision 2020]

The Director of Articulation and Transfer proposes updates to include information about transfer credit evaluations for Wright Path Program students. UAPC will consult with A & T about possible revisions during its AY 2025-2026 session.

3130 Dual Enrollment (College Credit Plus [date of last review/revision 2019]

No proposed changes at this time.

3140 Readmission [date of last review/revision 2018]

No proposed changes at this time.

3170 Second Undergraduate Degree Admissions [date of last review/revision 2018]

No proposed changes at this time.

3210 Ohio Articulation and Transfer Policy [date of last review/revision unknown]

There is currently a question of whether some or all of this policy, a large part of which repeats ODHE regulations, should be transferred from the Policy Index to the University Catalogue. UAPC will discuss with director of Articulation and Transfer.

3215 Transfer Credit Regulations [date of last review 2020]

As per recommendations of Director of Articulation and Transfer, this policy will be reviewed by UAPC in AY 2025-2026.

3220 Prior Learning Credit [Date of creation/review 2015]

Examine policy to include Cambridge Assessment International Education A and AS, in addition to updating the language around "Ohio Board of Regents". Also, 3220.5 is outdated because we do not offer UVC 1090 anymore and 3220.7 is not something we have been promoting.

3230 Ohio Transfer Module (OTM) [Last revised/reviewed 2018]

In consultation with Director of Articulation and Transfer, UAPC recommends sunsetting this policy, and transferring the list of courses and elements to the University Catalog.

3245 Transfer Student Requirements for IW [Last reviewed/reviewed unknown]

In consultation with Director of Articulation and Transfer, UAPC recommends sunsetting this policy, as information contained therein is now under revised policy 3240.

3260 Transfer Credit for D Grades [Date Created/Revised 2006]

This policy will be reviewed by UAPC in AY 2025-2026. It contains some obsolete language, and should be updated to reflect new Core and more recent transfer regulations. Recommend transferring ODHE language in to catalog, and retaining policy to apply to credit from non-public or non-OATN institutions.

3265 Transfer Policy for Plus/Minus Grading [Date Created/Revised 2006]

Former Provost Amy Thompson proposed creating a system of +/- grades for WSU. If the current administration wishes to pursue this change, this policy will need revision then.

3280 Transfer Credit for Advanced Placement (AP) [Date Created/revised 2006]

No proposed changes at this time. Clarify that threshold scores come from ODHE.

3285 Transfer Credit for Military Training, Experience and Coursework [Date Created/Revised 2019]

Update OBR to ODHE. Though 2011 directive from the state was the very beginning of the statewide effort, 2014 directive was what set the standards for accepting military credits. With Jason Anderson on board as part of the Center for Workforce Development, we should consult with him also to update the policy.

3315 Internship Policy [Date Created/revised 2014]

3320 Academic Classification based on Hours Completed [Date Created/revised 2017]

3340 Dean's List and President's List [Last revised 2025]

3350 Academic Standing and Probation

1 proposed change at this time: move minimum GPAs to two decimal points (e.g. 2.0= 2.00).

3365 Non-Academic Dismissal from Academic Units [Date of last revision 2016]

3370 Fresh Start Policy [Date last revised 2017]

No proposed changes at this time.

3375 Second Start Policy [Date last revised 2014]

3404 Required Advisor Approval [Date last revised 2025]

2024 Revision not yet posted to Policy Index.

3405 Auditing Classes [Date of Last Revision Unknown]

No proposed changes at this time.

3410 Required Selective Service Registration [Date last revised 2019]

One proposed change: it is recommended that this policy be renumbered, so that it falls under the index category of "Federal and State Regulations", Policies 3000-3090.

3420 Refunds and Refund Appeals [Date last revised 2018]

3430 Course Registration, Add Attendance and Administrative Drop [Date of Last Revision 2021]

The UAPC recommends working with University Registrar to split "Registration and Add" and "Attendance and Drop" as separate and revised policies.

3510 Withdrawal Policy [Date of last review 2018]

No proposed changes at this time.

3520 Course Repeats and Replacement [Date of last revision 2017]

The UAPC passed recommendations by University Registrar in 2025. Proposed changes tabled by Faculty Senate. Will work with Registrar to create acceptable revision.
