We are deleting the Teacher Leader concentration and thus revising the name from Educational Leadership: Student Affairs in Higher Education Administration to Student Affairs in Higher Education Administration. Thus, we are deleting the words Educational Leadership.

We are also deleting some courses. For example, we are deleting the four "one credit hour" sports management courses.

We are deleting the SAA 7630 – Diversity Issues course.

And we are deleting SPM 7010 Current Issues in American Sports and SAA 6660 Helping Skills for the SAHE Professional

With these changes, our program will be a 39-credit hour program to make it more competitive with our competitors, including the University of Dayton which is a 39-credit hour program.

Thus, this proposal is mainly for a program name modification to the Student Affairs in Higher Education Administration program with a few course deletions, and deletion of the Teacher Leader concentration due to low enrollment in that program.

The degree will be a Master of Education in Student Affairs in Higher Education Administration.

Subject: Faculty Senate - Follow-up on the Global Health Minor

Hi Colleagues,

The Global Health minor passed today, but I wanted to relay some additional background information in light of some questions on the Senate floor. The information below is from Amanda Hinson-Enslin, Ph.D., M.P.H., C.H.E.S, Associate Professor, Population & Public Health Sciences, Boonshoft School of Medicine (BSOM). This minor is housed within in BSOM, Department of Population and Public Health Sciences: https://medicine.wright.edu/population-and-public-health-sciences, and there is no Global Health major.

From Amanda:

The Global Health Minor is open to any students who complete the courses. Although public health students can complete the minor, other students in other degree programs can use their electives to complete the minor. Majors that we anticipate taking the minor include majors in: political science, nursing, social, work, psychology, organizational leadership, biology, international studies, business, foreign languages, and environmental health sciences.

While public health and global health are closely related fields, but they differ in scope, focus, and approach. Public health primarily concerns itself with the health of populations within a specific geographic area, such as a city, state, or country. It emphasizes disease prevention, health promotion, and improving healthcare systems within a defined community. In contrast, global health focuses on health issues that transcend national boundaries and require international collaboration. It works to improve health outcomes worldwide, particularly in low- and middle-income countries.

The strategies used in each field also differ. Public health relies on policies, regulations, and programs to address local or national health concerns, such as vaccination campaigns, sanitation improvements, and chronic disease prevention. Meanwhile, global health involves international partnerships, large-scale research initiatives, and interventions that address infectious diseases, maternal and child health, and global health disparities.

Key stakeholders also vary between the two fields. Public health efforts are typically led by government agencies like the Centers for Disease Control and Prevention (CDC), local health departments, healthcare providers, and community organizations. On the other hand, global health involves international organizations such as the World Health Organization (WHO), UNICEF, the World Bank, and non-governmental organizations (NGOs) that operate across multiple countries.

Additionally, each field examines different health determinants. Public health focuses on social, economic, and environmental factors that influence health within a particular region, while global health considers cross-border determinants like migration, climate change, pandemics, and global trade. While public health primarily focuses on populations within national borders, global health addresses international health challenges and solutions.

The Global Health Minor is focused on the skills the Consortium of Universities for Global Health have deemed and knowledge gaps, which are not in solely in the Public Health, BA, BS, or the Public Health Minor. The focus on political sciences, interpersonal advocacy, cultural competence, public health data interpretation, infectious disease investigation and epidemiological analysis. Also, this minor has students completing a required global health capstone project and a current global health events course that pull all of the aspects together, which are not required for the public health degrees.
